Notice of Public Footpath Diversion and Definitive Map and Statement Modification Order, and Notice of Public Footpath Creation and Definitive Map and Statement Modification Order

Public Footpath 49 Diversion and Definitive Map and Statement Modification Order Parish of St Georges And Priorslee 1 of 2019 .The Order, made on 6 September 2019, under Section 257 of the Town and Country Planning Act 1990 and Section 53A(2) of the Wildlife and Countryside Act 1981, if confirmed as made will divert Public Footpath 49 from its junction with Footpath 48 at grid reference 370945, 311111 where it continues in a general northerly direction for a distance of 70 meters to grid reference 370940, 311174 then continues west-north-west for a distance of 65 metres to a junction with a stone path at grid reference 370742,311294 TO a route commencing from a point at grid reference 370945, 311111 at the junction with Footpath 48 which continues north-west for a distance of 120 metres to a junction at grid reference 370742, 311294, and also provide for the required consequential amendment of the Definitive Map and Statement of Public Rights of Way for the County of Shropshire .

Public Footpath 49A Creation and Definitive Map and Statement Modification Order Parish of St Georges and Priorslee 2 of 2019. The Order made on 6 September 2019, under Section 26 of the Highways Act 1980 and Section 53A(2) of the Wildlife and Countryside Act 1981, if confirmed as made will create a public footpath commencing from its junction with Restricted Byway 54 (grid ref: 370792, 311294) with a width of 1.5m continues south-easterly for a distance of 140 m to its junction with Footpath 49 (grid ref: 370875, 311192) , and also provide for the required consequential amendment of the Definitive Map and Statement of Public Rights of Way for the County of Shropshire.

Please state the grounds on which they are made.

If no representations or objections are duly made to any of the Orders, or any parts of them, or if any so made are withdrawn, the Borough of Telford and Wrekin, instead of submitting the represented to or objected to Order to the Secretary of State for Environment, Food and Rural Affairs may itself confirm the Order. If any of the Orders are submitted to the Secretary of State for Environment, Food and Rural Affairs, any representations or objections which have not been withdrawn will be sent with it.
