<p>Every Member is required to register and disclose certain interests and those of their spouse partner or by the person with whom the member is living as if they were spouses/civil partners where they are aware of the existence of such interest:</p>	
<p>Employment, Office, Trade or Profession Any employment, office, trade, profession or vocation carried out for profit or gain by the member or by their spouse or civil partner or by the person with whom the member is living as if they were spouses/civil partners.</p>	<p>TELFORD + WREKIN Council</p>
<p>Sponsorship Any payment or provision of any other financial benefit (other than from the Council) made to the member during the 12 month period ending on the latest date referred to in paragraph 6 in the code of conduct for expenses incurred by them in carrying out their duties as a member, or towards their election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>	<p>N/A.</p>
<p>Contracts Any contract made between the member or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director¹ or a body that such person has a beneficial interest in the securities of¹¹) and the Council - (a) under which goods or services are to be provided or works are to be executed; and (b) Which has not been fully discharged</p>	<p>N/A</p>
<p>Land Any beneficial interest in land held by the member or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners which is within the area of the Council. <p>Licences Any licence (alone or jointly with others) held by the member or his/her spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners to occupy land in the area of the Council for a month or longer.</p>	<p>N/A</p>

<p>Corporate Tenancy Any tenancy where (to the member's knowledge)- (a) The landlord is the Council; and (b) The tenant is a body that the member, or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners is a partner of or a director* of or has a beneficial interest in the securities* of.</p>	<p>N/A</p>
<p>Securities Any beneficial interest held by the member or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners in securities of a body where – (a) That body (to the member's knowledge) has a place of business or land in the area of the Council; and (b) either- (i) The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) If the share capital of that body is of more than one class, the total nominal value of the shares in any one class in which the relevant person has a beneficial interest that exceeds one hundredth of the total issued share capital of that class</p>	<p>N/A</p>
