Every Member¹ is required to register and disclose certain interests and those of their Partner² where they are aware of the existence of such interests.

Employment, office, trade, profession or vocation | None

Any employment, office, trade, profession or vocation carried on for profit or gain by you or your partner

¹ 'member' means a member of the authority and includes a co-opted member

² Partner includes your spouse, civil partner or person with whom you are living as if they were your spouse or civil partner

<p><u>Sponsorship</u></p> <p>Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period³ in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses.</p> <p>This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p> <p><u>Contracts</u></p> <p>Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest⁴) and the Council</p> <p>(a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p>	<p>None</p> <p>None</p>

⁴ "body in which the relevant person has a beneficial interest" means a firm in which you or your partner is a partner or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest, and "director" includes a member of the committee of management of an industrial and provident society

⁵ "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;
