<p>Sponsorship Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period³ in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>	N/A
<p>Contracts Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest⁴) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p>	N/A

² Partner includes your spouse, civil partner or person with whom you are living as if they were your spouse or civil partner

³ "relevant period" means the period of 12 months ending with the day on which you give a notification of its existence

⁴ "body in which the relevant person has a beneficial interest" means a firm in which you or your partner is a partner or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and "director" includes a member of the committee of management of an industrial and provident

NOTES ON SENSITIVE INTERESTS

I understand that I must write to the Clerk of our Council and the Monitoring Officer to tell them about any disclosure of a disclosable pecuniary interest made at a meeting which is not already included above within 28 days of making the disclosure.
