

TELFORD & WREKIN COUNCIL (VARIOUS SCHOOLS) (PROHIBITIONS AND RESTRICTIONS OF WAITING) ORDER 2020

BOROUGH OF TELFORD & WREKIN in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III & IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby makes the following Order:-

1. This Order shall come into operation on **XX/XX/2020**, and may be cited as the Telford & Wrekin Council (Various Schools) (Prohibitions and Restrictions of Waiting) Order 2020.
2. The Orders specified in the Schedule of Revocations of this Order shall cease to have effect insofar as it relates to the extent specified in the Schedule of Revocations to this Order.
3. (1) In this Order:-
 - "Authorised Parking Place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;
 - "Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 2000.
 - "Parking Disc" means a disc issued by a local authority, capable of showing the quarter hour period during which a period of waiting begins.
- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (a) A Disabled Person's Badge in the relevant position, when:-
 - (i) In the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
 - (b) a Parking Disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- (3) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
4. (1) Nothing in Article 6 and 7 shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of roads specified in Schedule One and Schedule Two to this order for so long as may be necessary to enable:-
 - (a) persons to board or alight from a vehicle;

- (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
 - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
 - (c) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
 - (d) a vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
 - (e) a vehicle to wait at or near to any premises situated on or adjacent to the sides of lengths of roads for so long as such waiting is reasonably necessary in connection with any wedding or funeral; or
 - (f) the vehicle to be used for Fire Brigade, Ambulance or Police purposes.
- (2) Nothing in Article 6 and 7 to this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded onto or unloaded from the vehicle on the sides of lengths of roads specified in the Schedule One and Two to this Order, at any time.
- (3) Nothing in Articles 6 and 7 to this Order shall render it unlawful to cause or permit any vehicle:
- (a) to wait upon an Authorised Parking Place
- (4) Nothing in Articles 6 and 7 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a Parking Disc (on which the driver, or person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on any of the sides of lengths of roads referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment
6. Save as provided in Article 4 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time on the lengths of roads specified in Schedule One of this Order.
7. Save as provided in Article 4 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between 8am and 6pm, on every day on the sides and lengths of roads specified in Schedule Two of this order

8. No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to stop between the Monday – Friday 8am – 5pm and on the sides of lengths of roads specified in Schedule Three of this order.

Schedule One (No waiting at any time)	
1. Beaconsfield, Brookside (the east side)	<p>from a point 67m south of its junction with Briarwood to a point 84m south-east of its junction with Briarwood</p> <p>from the side of no.115 Beaconsfield to the side of no.116 Beaconsfield</p>
2. Beaconsfield, Brookside (the south-east side)	from outside no.125 to the school gates
3. Beaconsfield, Brookside (the south-west side)	from the school gates at the bottom of Beaconsfield to a point 40m North of the school gates
4. Beaconsfield, Brookside (the west side)	from the car park on the right hand side heading towards the school at the bottom of Beaconsfield to a point 30m north of car park on the right hand side heading towards the school at the bottom of Beaconsfield
5. Holyhead Road, Wellington (the north side)	from its junction with New Church Road for a distance of 21m in an easterly direction
6. Holyhead Road, Wellington (the south side)	from its junction with Limekiln Lane for a distance of 43m in a westerly direction
7. Riddings Close, Ketley (both sides)	from a point 21m south of its junction with Woodside Road to its junction with Woodside Road
8. Riddings Close, Ketley (the east side)	<p>from a point 7m north of its junction with Mount Side to its junction with Mount Side</p> <p>from its junction with Mount Side for a distance of 23m</p>
9. Rowan Avenue, Dawley (the east side)	from its junction with Rowan Avenue in a southerly direction for a distance of 28m
10. Rowan Avenue, Dawley (the west side)	from its junction with Rowan Avenue in a southerly direction for a distance of 22m

11. Severn Drive, Wellington (the east side)	from a point 17m north of its junction with the access to Dothill Primary School for a distance of 29m in a northerly direction
12. Severn Drive, Wellington (the south-east side)	from a point 41m south of the junction with the access to Dothill Primary School for a distance of 22m in a south-westerly direction
13. Severn Drive, Wellington (the west side)	from a point 10m south of its junction with the access to Dothill Primary School for a distance of 20m in a northerly direction from a point 30m north of its junction with the access to Dothill Primary School for a distance of 110m in a northerly direction around the turning head
14. Woodside Road, Ketley (the south side)	from its junction with Riddings Close in a westerly direction for a distance of 8m from its junction with Riddings Close for a distance of 8m

1. Limekiln Lane, Wellington (the south-west side)	from a point 12m south east of its access to School for a distance of 33m in a south-easterly direction

1. Capewell Road, Trench (the north side)	from a point 7m east of the foot bridge crossing the A442 to a point 49m east of the foot bridge crossing the A442
2. Granville Avenue, Newport (the south side)	from a point 117m north east of its junction with Station Road for a distance of 43m in a north easterly direction
3. Southfield, Sutton Hill (the north-east side)	from a point 22m north-west of its junction with the access to Sir Alexander Fleming Primary School to a point 22m south-east of its junction with the access to Sir Alexander Fleming Primary School
