

TELFORD & WREKIN COUNCIL (HARTSHILL, OAKENGATES, TELFORD) (PROHIBITION AND RESTRICTION OF WAITING) ORDERS 2020

BOROUGH OF TELFORD & WREKIN in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby makes the following Order:-

1. This Order shall come into operation on Friday 26th March 2021, and may be cited as the Telford & Wrekin Council (Hartshill, Oakengates, Telford) (Prohibition and Restriction of Waiting) Orders 2020.
2. The Orders specified in the Schedule of Revocations of this Order shall cease to have effect insofar as it relates to the extent specified in the Schedule of Revocations to this Order.
3. (1) In this Order:-
 - "Authorised Parking Place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;
 - "Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 2000.
 - "Parking Disc" means a disc issued by a local authority, capable of showing the quarter hour period during which a period of waiting begins.
- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (a) A Disabled Person's Badge in the relevant position, when:-
 - (i) In the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
 - (b) a Parking Disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- (3) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
4. (1) Nothing in Article 6 and 7 shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of roads specified in Schedule One and Schedule Two to this order for so long as may be necessary to enable:-
 - (a) persons to board or alight from a vehicle;

- (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
 - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
 - (c) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
 - (d) a vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
 - (e) a vehicle to wait at or near to any premises situated on or adjacent to the sides of lengths of roads for so long as such waiting is reasonably necessary in connection with any wedding or funeral; or
 - (f) the vehicle to be used for Fire Brigade, Ambulance or Police purposes.
- (2) Nothing in Article 6 and 7 to this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded onto or unloaded from the vehicle on the sides of lengths of roads specified in Schedule One and Schedule Two to this Order.
- (3) Nothing in Article 6 and 7 to this Order shall render it unlawful to cause or permit any vehicle:
- (a) to wait upon an Authorised Parking Place
- (4) Nothing in Article 6 and 7 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a Parking Disc (on which the driver, or person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on any of the sides of lengths of roads referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).

5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment


6. Save as provided in Article 4 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time on the lengths of roads specified in Schedule One of this Order
7. Save as provided in Article 4 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait during Monday to Friday between the times of 08.30am – 09.30am and 14.30pm – 15.45pm on the sides and lengths of roads specified in Schedule Two of this order

SCHEDULE OF REVOCATIONS	
Items to be revoked from: Telford & Wrekin Council (Various Roads, St Georges, Oakengates, Priorslee And Trench) (Prohibition of Waiting) Order 2015	
Schedule 2 No waiting – at any time on all days	
1. Hartsbridge Road, Oakengates (Both sides)	from a point 14m south of the centreline of its junction with Stallard Court for a distance of 24m in a northerly direction
2. Hartsbridge Road, Oakengates (Both sides)	from the centreline of its junction with Hartshill for a distance of 10m in a southerly direction
3. Hartshill, Oakengates (the North side)	from a point 16m west of the centreline of its junction with Hartshill Avenue for a distance of 32m in a easterly direction
4. Hartshill, Oakengates (the North side)	from a point 122m east of the centreline of its junction with Hartshill Avenue for a distance of 50m in a easterly direction
5. Hartshill, Oakengates (the South side)	from a point 26m west of the centreline of its junction with Hartsbridge Road for a distance of 130m in a easterly direction
6. Hartshill, Oakengates (the South side)	from a point 29m west of the centreline of its junction with Charlton Street for a distance of 69m in a westerly direction
7. Hartshill, Oakengates (the South side)	from a point 194m west of the centreline of its junction with Hartsbridge Road for a distance of 50m in a easterly direction

Schedule One (No waiting at any time)	
1. Hartsbridge Road, Oakengates (both sides)	from its junction with Hartshill for a distance of 10m in a southerly direction
2. Hartshill, Oakengates (the north side)	from a point 13.5m west of the centreline of Hartshill Avenue for a distance of 29 m in an easterly direction
3. Hartshill, Oakengates (the south side)	from its junction with Hartsbridge Road for a distance of 4m in an easterly direction
4. Hartshill Avenue, Oakengates (both sides)	from its junction with Hartshill in a northerly direction for a distance of 8m

Schedule Two (No Waiting - Part Time Mon-Fri 8.30am-9.30am and 2.30pm-3.45pm)	
1. Hartshill, Oakengates (the north side)	From the boundary of No. 7 Harts Court for a distance of 314m in a westerly direction
2. Hartshill, Oakengates (the south side)	From the east boundary of No. 43 for a distance of 66m in a westerly direction
3. Hartshill, Oakengates (the south side)	From a point 38m west of its junction with Charlton Street in a westerly direction for a distance of 155m
