

**TELFORD AND WREKIN COUNCIL (VARIOUS ROADS, CHETWYND ASTON AND WOODCOTE)  
(7.5 TONNES RESTRICTED ACCESS WEIGHT RESTRICTION) TRAFFIC REGULATION ORDER  
2021**

**Notice is hereby given** that Borough of Telford & Wrekin has Made the above Order under Sections 1(1), 2(1), 2(2), and 2(4) of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The Order will come into effect on 10<sup>th</sup> September 2021.

The effect of the Order will be to prohibit access to goods vehicles exceeding 7.5 tonnes from travelling along the below lengths of roads but will allow lawful access to premises:

A41 Junction to Pave Lane Farm, Woodcote, Newport	From its junction with A41 Woodcote, Newport for its entire length.
Pave Lane, Chetwynd Aston, Newport	From its junction with A41 Junction to Pave Lane Farm for its entire length.
Pitchcroft Lane, Woodcote, Newport	From its junction with A41 Junction to Pave Lane Farm for its entire length.
Littlehales Road, Chetwynd Aston, Newport	From its junction with Pitchcroft Lane, in a northerly direction, to its junction with Pave Lane, Chetwynd Aston, Newport
A41 Junction Link to Field House Lane, Newport	From its junction with Chetwynd Aston Road, Chetwynd Aston, Newport for its entire length.
Field Aston Lane, Field Aston, Newport	From its junction with Chetwynd Aston Road, Chetwynd Aston, Newport for its entire length.
Chetwynd Aston Spur - Turning Head, Chetwynd Aston, Newport	From its junction with Chetwynd Aston Road, Chetwynd Aston, Newport for its entire length.
