## TELFORD & WREKIN COUNCIL (VARIOUS ROADS, HOLLINSWOOD, TELFORD) (PROHIBITION OF WAITING) ORDER 2020

Notice is hereby given that Borough of Telford and Wrekin in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby make the following Order: Telford & Wrekin Council (Various Roads, Hollinswood, Telford) (Prohibition of Waiting) Order 2020. This order will come into effect on Friday 6<sup>th</sup> March 2020

- 1. When this Order comes into effect, subject to certain exceptions set out in the Order;
  - Waiting will be prohibited at all times on the sides of the lengths of roads specified in the Schedule to this Order.
- 2. A copy of the draft Order, the relevant plans, a statement of the Council's reasons for proposing to make the Order, may be examined during usual office hours at the Council's Offices at Addenbrooke House, Ironmasters Way, Telford, TF3 4NT. - 3. Any persons wishing to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirements of the Act or of any instrument made under the Act have not been complied with, that person may within 6 weeks from the date on which the Order is made, apply for that purpose to the High Court

## Schedule (No waiting at any time)

- Dale Acre Way, Hollinswood (the south side) from a point 37m east of the centreline of Deepdale in a westerly direction to a point 2m east of the centreline of Downemead
- 2. Dale Acre Way, Hollinswood (South side) from a point 76m north-west of the centreline of Dalelands in a north-westerly direction to a point 31m south-east of the centreline of Dunsheath
- 3. Dallamoor, Hollinswood (both sides) from a point 10m from its junction with Dallamoor for a distance of 26m in a north easterly direction
- 4. Dallamoor, Hollinswood (the north side) from its junction with Dale Acre Way for a distance of 83m in a westerly direction
- 5. Dallamoor, Hollinswood (the south side) from its junction with Dale Acre Way for a distance of 84m in a westerly direction
- 6. Darliston, Hollinswood (both sides) from its junction with Dale Acre Way for a distance of 15m in a southerly direction
- 7. Deepdale, Hollinswood (both sides) from a point 12m from its junction with Dale Acre Way for a distance of 53m in a northerly direction
- 8. Downemead, Hollinswood (the east side) from a point 50m south of its junction with Dale Acre Way in a southerly direction for a distance of 99m
- Downemead, Hollinswood (the west side) from a point 58m south of its junction with Dale Acre Way for a distance of 76m, in a southerly direction
- Downemead, Hollinswood (the west side) from a point 13m south of its junction with Dale Acre Way in a southerly direction for a distance of 45m
- 11. Dudmaston, Hollinswood (the east side) from a point 9m into Dudmaston (side road) for a distance 68m in a southerly direction
- 12. Dudmaston, Hollinswood (the north side) from its junction with Dale Acre Way for a distance of 29m in an easterly direction
- 13. Dudmaston, Hollinswood (the west side) from its junction with Dale Acre Way for a distance of 80m in an southerly direction
- 14. Dunsheath, Hollinswood (the north side) from its junction with Dunsheath for a distance of 90m in an easterly direction
- 15. Dunsheath, Hollinswood (the south side) from a point 23m from its junction with Dale Acre Way for a distance of 79m in an easterly direction
