

Borough of Telford & Wrekin - Traffic Regulation Order Notice of Proposal

Notice is hereby given that Borough of Telford and Wrekin (the Council) proposes to make the following Traffic Regulation Order in accordance with the provisions of the Road Traffic Regulation Act 1984.

Telford & Wrekin Temporary Prohibition of Waiting (Carriageway, Layby and Footways The Wharfage, High Street and Tontine Hill, Ironbridge) Order 2020

The Order is needed to minimise danger that may arise in connection with the current COVID-19 crisis and to enable social distancing between pedestrians.

The effect of the Order will be to:

- (1) Retain prohibition of waiting arrangements for vehicles in the lengths of road in Part 1 of the Schedule.
- (2) Retain the prohibition of waiting arrangement for vehicles in the footways comprised in the lengths of road in Part 2 of the Schedule.
- (3) Retain the restriction of waiting arrangements for vehicles in the length of road in Part 3 of the Schedule.
- (4) Suspend The Telford & Wrekin Council (Various Roads, The Gorge) (Revocation, Prohibition of Waiting, On Street Parking Place and Restriction of Stopping) Order 2013 insofar as it relates to the waiting of vehicles on the length of road in Part 3 of the Schedule.
- (5) Suspend The Borough of Telford & Wrekin Temporary Prohibition of Waiting (Footways on Tontine Hill, Footways and Layby on High Street, Ironbridge) Notice.

Alternative parking is available in Station Yard Car Park, Waterloo Street Car Park, The Wharfage Car Park and Dale End Car Park.

The Order shall come into operation on 12 June 2020 for a period of 18 months.

High Street, Ironbridge (South side)	<p>From a point approximately 82m west of its junction with Waterloo Street for a distance of approximately 19m in a westerly direction.</p> <p>From a point approximately 107m west of its junction with Waterloo Street for a distance of approximately 23m in a westerly direction</p>

High Street, Ironbridge	For its entire length

High Street, Ironbridge (North side)	From a point approximately 110m west of its junction with Church Hill for a distance of approximately 12m in a westerly direction
