

### **Telford and Wrekin Council Off-Street Parking Places – Ironbridge Order 2020**

Notice is hereby given that Borough of Telford & Wrekin propose to make the Telford & Wrekin Council Off-Street Parking Places – Ironbridge Order 2020 under the Road Traffic Regulation Act 1984, the effect of this Order is as follows:

1. The parking places subject to this Order (“the Parking Places”) are located in Ironbridge, Telford at Dale End, Ironbridge Central (at the site of the old station yard off Ladywood), The Square, The Wharfage & Waterloo Street.
2. The Telford and Wrekin Council Off-Street Parking Places Order 2014 – Ironbridge will cease to have effect in its entirety.
3. This Order shall introduce arrangements for use of the Parking Places, introduce Initial Charges and certain exemptions (for Disabled Persons Vehicles, Permit Holders and Public Service Vehicles), maximum permitted parking periods and introduce Penalty Charges for contravention of this Order.
4. On any day between 1000 hours and 1700 hours the initial charges in respect of a Vehicle or Trailer parked on the Parking Places at Dale End or Ironbridge Central are as follows:  
Where a Vehicle or Trailer is parked for
  - (i) up to 2 hours - £1.60
  - (ii) more than 2 hours - £2.90
5. On any day between 1000 hours and 1700 hours the initial charges in respect of a Vehicle or Trailer parked on the Parking Place at The Square, are as follows:  
Where a Vehicle or Trailer is parked for
  - (i) up to 30 minutes - £0.80
  - (ii) up to 1 hour - £2.90
6. On any day between 1000 hours and 1700 hours the initial charge in respect of a Vehicle or Trailer parked on the Parking Places at The Wharfage or Waterloo Street are as follows:  
Where a Vehicle or Trailer is parked for
  - (i) up to 3 hours - £2.80
7. the Driver of a Vehicle towing a Caravan into that Parking Place and the driver of a Motorhome shall not permit the Caravan or the Motorhome to wait in that Parking Place between the hours of 23:00 hours and 06:00 hours
