

TELFORD & WREKIN COUNCIL (HADLEY, TELFORD) (PROHIBITION OF WAITING & DISABLED BAY) EXPERIMENTAL ORDER 2020
Notice is hereby given that the Borough of Telford and Wrekin in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following order.

TELFORD & WREKIN COUNCIL (HADLEY, TELFORD) (PROHIBITION OF WAITING & DISABLED BAY) EXPERIMENTAL ORDER 2020

1. This Experimental Order will come into effect on Tuesday 6th October 2020 for a period not exceeding eighteen months.
2. The effect of this Experimental Order: is parking will be prohibited at all times along the sides and lengths of road as described in Schedule One. Waiting will be restricted to the use of vehicles displaying a valid Disabled Person's Badge and Parking Disc at all times on the length of roads specified in Schedule Two of this Notice. **(Various Roads, Hadley & Leegomery, Telford) (Prohibition & Restriction Of Waiting & Restriction Of Stopping) Order 2013 & Telford & Wrekin Council (Various Roads, Hadley, Hortonwood, Apley & Lilleshall, Telford) (Prohibition Of Wating) Order 2019** shall cease to have the effect in so far as it relates to the sides of the lengths of roads specified in Schedule Revocations below.

Schedule One (Prohibition of Waiting)	
1. Crescent Road, Hadley (the north side)	from its junction with the centreline of Manse Road in a westerly direction for a distance of 133 from the junction with Manse Road in a easterly direction for a distance of 10m
2. Crescent Road, Hadley (the north-west side)	from a point 22m south west of the junction with the centreline of Mafeking Road in a north easterly direction for a distance of 208m
3. Crescent Road, Hadley (the south side)	from a point 14m east of the center of the junction with Manse Road in a easterly direction for a distance of 37m
4. Crescent Road, Hadley (the south-east side)	from a point 22m south west of its junction with the centreline of Mafeking Road in a north easterly direction for a distance of 33m
5. Mafeking Road, Hadley (both sides)	from the junction with Crescent Road in a north westerly direction for a distance of 24m
6. Manse Road, Hadley (both sides)	from its junction with Crescent Road in a northerly direction for a distance of 11m
7. Manse Road, Hadley (the east side)	from a point 11m north of its junction with Crescent Road in a northerly direction for a distance of 101m

Schedule Two (Disabled Parking)	
1. Crescent Road, Hadley (the south side)	from a point 51m west of its junction with Manse Road for a distance of 6m in a westerly direction
2. Crescent Road, Hadley (the south-west side)	from a point 173m west of its junction with Manse Road for a distance of 6m in a westerly direction
3. Manse Road, Hadley (the west side)	from a point 20m north of its junction with Crescent Road for a distance of 6m in a northerly direction

Schedule Three (Revocations)	
The traffic restrictions imposed in the (Various Roads, Hadley & Leegomery, Telford) (Prohibition & Restriction Of Waiting & Restriction Of Stopping) Order 2013 at the times referred to below in relation to the sides and lengths of road set out below in this paragraph 1 are, pursuant to Article 2 above, hereby suspended and shall cease to have effect while this Order is in force	
No waiting at any time (i) Crescent Road, both sides, from a point approximately 23m north-east of its junction with Mafeking Road for a distance of approximately 45m in a south-westerly direction. (ii) Crescent Road, both sides, for the entire length of the turning head area up to the westerly building line of property 68 (iii) Mafeking Road, both sides, from its junction with Crescent Road in a north-westerly direction for a distance of approximately 24m in a north-westerly direction	
No Waiting - Part Time 2 Mon-Fri 8am-9.30am and 2.30pm-4pm Crescent Road, both sides, for the entire length of the turning head area up to the westerly building line of property number 54.	
No Stopping - School Keep Clear Mon-Fri 8am-5pm (i) Crescent Road, the south side, From a point approximately 37m west of the centreline of Manse Road for a distance of approximately 26m in a westerly direction. (ii) Crescent Road, the south side, From a point approximately 8m west of the centreline of Manse Road for a distance of approximately 26m in a easterly direction.	
The traffic restrictions imposed in the Telford & Wrekin Council (Various Roads, Hadley, Hortonwood, Apley & Lilleshall, Telford) (Prohibition Of Wating) Order 2019 at the times referred to below in relation to the sides and lengths of road set out below in this paragraph 2 are, pursuant to Article 2 above, hereby suspended and shall cease to have effect while this Order is in force	
No waiting at any time (i) Crescent Road, the south side, from a point 48m east of the centreline of Manse Road in a westerly direction to a point opposite the westerly building line of property No.54. (ii) Manse Road, both sides, from its junction with Crescent Road in a northerly direction for a distance of 10m	

3. A copy of the Experimental Order, the relevant plans, a statement of the Council's reasons for making the Order and details of any revocations may be examined online at www.telford.gov.uk/tro
4. In due course, the Council will consider whether or not the provisions of the Experimental Order should be continued in force indefinitely. Within a period of six months beginning with the day on which the Experimental Order came into force, or if any or all of the Experimental Order provisions are varied or modified by the Council, beginning with the day the latest variation or modification came into force, any person may object to the making permanent of the Experimental Order.
