




Income Domain



Income Domain

The Income Deprivation domain measure the proportion of the population in an area experiencing deprivation relating to low income. The definition of low income used includes both those people that are out-of-work, and those that are in work but who have low earnings (and who satisfy the respective means tests).

Most deprived

- Some 19 areas in Telford and Wrekin are ranked in the 10% most deprived nationally for income (Brookside x2, Madeley & Sutton Hill x4, Woodside x4, Malinslee & Dawley Bank x3, Hadley & Leegomery, Colledge, The Nedge, Dawley & Aqueduct x2, Donnington). A further ten areas are ranked in the 10-20% most deprived nationally in 2019 (St Georges, Woodside, The Nedge x2, Haygate, Donnington, Oakengates & Ketley Bank, Arleston, Hadley & Leegomery x2).
- A quarter of Telford and Wrekin's population (26%) some 45,000 people are estimated to live in areas ranked in the 20% most deprived nationally for income, with 15% (29,000 people) living in the 10% most deprived areas.
- The most deprived LSOA in Telford and Wrekin for income is located in Brookside and is ranked 263 nationally (1 being most deprived) placing it in the top 1% most deprived areas nationally.

Least deprived

- A total of six areas in Telford and Wrekin are ranked in the 10% least deprived nationally (Priorslee x2, Newport North & West, Newport South & East, Ercall, Shawbirch) with a further seven areas ranked in the 10-20% least deprived nationally (Edgmond & Ercall Magna x3, Muxton, Apley Castle, Priorslee, The Nedge).
- It is estimated that 12% of the Borough's population (20,000 people) live in areas ranked in the 20% least deprived nationally, with 5% (9,200 people) living in the 10% least deprived areas.

Change since 2015

- In 2015 there were a total of 17 areas in the 10% most deprived nationally, all but one of these (Woodside) remain there for 2019 with three more areas moving from decile 2 into decile 1 (Colledge, The Nedge, Madeley & Sutton Hill).
- A total of 24 areas have seen a change to a more deprived decile since 2015, with these changes seen across the range of deciles, not just more deprived areas.
- Some 20 areas have seen an improvement to a less deprived decile since 2015, with one area in Edgmond improving by two deciles.
- Although just six areas in the 20% most deprived have seen a fall into a more deprived decile, around half of these areas (14 out of 29) have seen a worsening of relative deprivation since 2015.
