## The following papers must be delivered by hand:

- 1: Nomination form
- 2: Candidate's home address form
- 3: Candidate's consent to nomination

### The following papers can be delivered by hand or by post:

- 4: Certificate of authorisation
- 5: Request for a party emblem
- 6: Notification of election agent
- 7: Notification of sub-agent

The notice of election published by the Police Area Returning Officer (PARO) will specify the times and exact location to which nomination papers **must** be delivered.

Ensure that where signatures are required, you submit the **original signed version** of each completed paper. Documents without original signatures cannot be accepted.

The UK government has laid legislation to reduce the number of subscribers that are required by each candidate for elections taking place on 6 May 2021. This legislation is expected to come into force in early March 2021. We have updated our guidance and resources to reflect this proposed legislation and the updated requirements for the nominations process. Please note that paper 1a: the Nomination paper, contains more space for subscribers than is needed. The Cabinet Office has published a table outlining how many subscribers are required for each Police area, which you can find here

# **General Data Protection Regulation (GDPR)**

Data protection legislation applies to the processing of all personal data. Please contact the <u>Information Commissioner's Office</u> for further information about how the legislation affects you.

When collecting subscriber information, you should point out what the information will be used for, and how personal data will be processed and kept secure. The lawful basis to collect the information in these forms is that it is necessary for the performance of a task carried out in the public interest and exercise of official authority as set out in the Representation of the People Act 1983 and associated regulations.

You should also explain that the information will be shared with the PARO. For further information on data protection and data processing you should refer to the PARO's privacy notice on their website.

This checklist is designed to assist candidates standing in a Police and Crime Commissioner election in preparing to submit their nomination, and should be read alongside the Electoral Commission's <u>Guidance for candidates and agents</u>.

Nomination form (all candidates)	
Insert the name of the police area and poll date – check with the PARO if you are unsure.	
Add your full name – title, surname and all other names in full in the relevant boxes.	
Optional – Use the commonly used name(s) box(es) if you commonly use a name that is different from any forename or surname that you have and you want it to be used instead of your full name.	
Description – Party candidates can use a party name or description registered with the Electoral Commission and must match the details shown on the required certificate of authorisation from that party; others can use 'Independent' (and/or 'Annibynnol' in Wales) or leave this blank. Whatever you enter in this box will appear as your description on the ballot paper.	
Subscribers - The number of subscribers required for the May 2021 polls is twice the number of local authorities (or part of such an authority) in the police area. The Cabinet Office has published a table outlining how many subscribers are required for each Police area, which you can find <a href="here">here</a> Each subscriber also have their electoral number printed. Use your copy of the electoral register to make sure the electoral numbers of all subscribers are accurate. The register will also indicate which voting area (local authority) the elector is from. When collecting subscriber information ensure that you explain what the information will be used for and that the information will be shared with the PARO.	
Please include the name of the candidate, description (if any) and name of the police area on each page in case the pages become separated at a later time.	
Method of submitting the nomination form to the PARO: by hand. Only you, your election agent (provided you have given notice of appointment to the PARO or the notice is submitted when the nomination form is delivered), or the proposer or seconder shown on the nomination form, may deliver the nomination form.	
Candidate's home address form (all candidates)	
Add your full name and your home address in full.	
You can choose to ask the PARO not to publish your home address on the statement of persons nominated. If you don't want your home address to be published by the PARO, complete the second part of the form.	
If you are completing part 2, you must state an electoral area in the police area in which you are registered to vote. You could, for example, use the ward and council name or the UK Parliamentary constituency in which you are registered.	
If you are completing part 2, you must sign the form.	
Method of submitting the home address form to the PARO: by hand. Only you, your election agent (provided you have given notice of appointment to the PARO or the notice is submitted when the home address form is delivered), or the proposer or seconder shown on the nomination form, may deliver the home address form.	
Candidate's consent to nomination (all candidates)	
Complete all the details on the form and read the declaration carefully. Make sure that you read the Electoral Commission guidance on standing for election as well as the legislation listed. If you are not sure if you are able to stand you should contact your	

employer (where relevant), consult the legislation or, if necessary, take your own independent legal advice. If you are satisfied that you meet all of the criteria listed and so are eligible to stand, sign the declaration.	
Add your full date of birth.	
Sign and date the document in the presence of another person. Don't sign the consent form earlier than 31 calendar days before the deadline for submitting your nomination papers.	
Get the other person to complete and sign the witness section.	
Method of submitting the consent to nomination form to the PARO: by hand. There are no restrictions on who can deliver it, but it should be someone you trust.	
Certificate of authorisation (party candidates only)	
Ensure the certificate contains the candidate's full name and that the other details are completed.	
Check the certificate allows the registered party name or description given on the nomination paper to be used (or allows the candidate to choose to use the party name or any registered description).	
Ensure it is issued by the party Nominating Officer (or someone that they have authorised to issue it on their behalf) and that is the original copy signed by that person.	
Method of submitting the certificate of authorisation to the PARO: by hand or by post. There are no restrictions on who can deliver it, but it should be someone you trust. It cannot be submitted by fax, e-mail or other electronic means.	
Request for party emblem (party candidates only)	
Write the name or description of an emblem registered by the party and published on the Electoral Commission's website.	
Ensure the request is made by the candidate or on behalf of the candidate.	
Method of submitting the emblem request form to the PARO: by hand or by post. There are no restrictions on who can deliver it, but it should be someone you trust.	
Notification of election agent (all candidates)	
Give the name and address of your appointed election agent.	
Ensure the appointed agent signs the form showing their acceptance.	
Method of submitting the notification form to the PARO: by hand or by post. There are no restrictions on who can deliver it, but it should be someone you trust.	
Notification of sub-agent (all candidates)	
Candidates may appoint one or more sub-agents to act on behalf of the election agent in the police area, but each must have a separate area (e.g. you could appoint one sub-agent for each local authority area in the police area). Sub-agent areas must not overlap. Decide if you wish to appoint any sub-agents and the extent of the area to be covered by each of them.	
Give the name and address of your appointed sub-agent.	
Method of submitting the notification form(s) to the PARO: by hand or by post. There are no restrictions on who can deliver these, but it should be someone you trust.	
Deposit (all candidates)	
Confirm with the PARO that your preferred method of payment is acceptable, and deposit £5,000 with the PARO by the deadline for nominations.

#### **Notes**

- Candidates and election agents should read the rules for filling up nomination papers and other provisions relating to nomination and deposits contained in the PCC Elections Rules.
- 2. Where a candidate is commonly known by some title they may be described by their title as if it were part of their surname.
- 3. Where a candidate commonly uses a name that is different from any other name they have, the commonly used name will appear on the ballot paper instead of any other name.
- 4. The ballot paper will show the other name if the Police Area Returning Officer thinks that the use of the commonly used name a) may be likely to mislead or confuse electors or b) is obscene or offensive.
- 5. A person's electoral number is his/her number in the electoral register to be used at the election, including the distinctive letter of the parliamentary polling district in which he/she is registered.
- 6. An elector may not subscribe more than one nomination paper for the same Police and Crime Commissioner election.
- 7. In this form "elector"-
  - a) means a person whose name is registered in the register of local government electors for the electoral area in question on the last day for the publication of notice of election; and
- b) includes a person then shown in the register as below voting age if (but only if) it appears from the register that he/she will be of voting age on the day fixed for the poll.
- 8. However, a person who has an anonymous entry in the register of local government electors cannot nominate a candidate for election.

A candidate supported by a certificate of authorisation signed by the Nominating Officer of a political party (or someone on their behalf) may use the party name or a description allowed by that certificate and registered with the Electoral Commission. A candidate may stand on behalf of two or more different parties and use a registered joint description if supported by certificate of authorisation from each of the parties. Any candidate may alternatively use the description of 'Independent' (and/or 'Annibynnol' in Wales), or leave the description box blank.
