TELFORD & WREKIN COUNCIL (VARIOUS ROADS, DAWLEY, TELFORD) (PROHIBITIONS AND RESTRICTIONS OF WAITING) TRAFFIC REGULATION ORDER 2021

Notice is hereby given that Borough of Telford and Wrekin in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby propose to make the following Order: Telford & Wrekin Council (Various Roads, Dawley, Telford) (Prohibitions and Restrictions of Waiting) Traffic Regulation Order 2021.

1. When this Order comes into effect;
 - a. Waiting will be prohibited at all times on the length of roads specified in Schedule One to this Order to the extent specified.
 - b. Waiting will be prohibited Monday – Friday between the times of 8.30am-9.30am and 2.30pm-3.30pm on the lengths of roads specified in the Schedule Two.
 - c. The Orders specified in the Schedule of Revocation of this Order shall have the effect of revoking or removing the references to the specified Order to the extent specified.

Schedule One (No waiting at any time)	
1. Concorde, Telford And Wrekin (the north-east side)	from a point 11.5 metres north-west of the centreline of its junction with Old Office Close in a south-easterly direction to a point 9 metres south-east of that junction.
2. Concorde, Telford And Wrekin (the south-west side)	from a point 11 metres south-east of the centreline of its junction with Old Office Road in a north-westerly direction to a point 14 metres north-west of that junction.
3. Conroy Drive, Telford And Wrekin (the north-east side)	from its junction with Old Office Road in an easterly direction for a distance of 15 metres.
4. Conroy Drive, Telford And Wrekin (the south-west side)	from its junction with Old Office Road in a south-easterly direction for a distance of 15 metres.
5. Old Office Close, Telford And Wrekin (the north-west side)	from its junction with Concorde in a north-easterly direction for a distance of 13.5 metres.
6. Old Office Close, Telford And Wrekin (the south-east side)	from its junction with Concorde in a north-easterly direction for a distance of 13.5 metres.
7. Old Office Road, Telford And Wrekin (the north side)	from a point 35 metres south-west of its junction with Ladygrove in an easterly direction following the kerb alignment to its junction with Conroy Drive.
8. Old Office Road, Telford And Wrekin (the north-west side)	from its junction with Old Office Road in a north-easterly direction for a distance of 15 metres.

	<p>from its junction with Concorde in a south-westerly direction for a distance of 12 metres.</p> <p>from a point 70 metres north-east of the centreline of its junction with Gregson Walk in a north-easterly direction for a distance of 17 metres.</p>
9. Old Office Road, Telford And Wrekin (the south side)	from a point 25 metres west of the centreline of its junction with Ladygrove in an easterly direction to its junction with Conroy Drive an approximate distance of 60 metres.
10. Old Office Road, Telford And Wrekin (the south-east side)	<p>from a point 70 metres north-east of the centreline of its junction with Gregson Walk in a north-easterly direction for a distance of 17 metres.</p> <p>from its junction with Conroy Drive in a north-easterly direction for a distance of 15 metres.</p> <p>from its junction with Concorde in a south-westerly direction for a distance of 12 metres.</p>

Schedule Two
(No Waiting - Part Time 2 Mon-Fri 8.30am-9.30am and 2.30pm-3.30pm)

1. Conroy Drive, Telford And Wrekin (the north-east side)	from a point 15 metres south-east of the centreline of its junction with Old Office Road in a south-easterly direction for a distance of 23 metres.
2. Conroy Drive, Telford And Wrekin (the south-west side)	from a point 15 metres south-east of the centreline of its junction with Ladygrove in a south-easterly direction for a distance of 20 metres
3. Old Office Road, Telford And Wrekin (the north-west side)	from a point 15 metres north-east of its junction with Old Office Road in a north-easterly direction for a distance of 89 metres.
4. Old Office Road, Telford And Wrekin (the south-east side)	from a point 15 metres north-east of the centreline of its junction with Old Office Road in a north-easterly direction for a distance of 43 metres

Old Office Road, the north-east side	From a point approximately 11m north west of the centreline of Old Office Road for a distance of approximately 26m in a south easterly direction.
