NOTICE OF SPEED LIMIT PROPOSAL
TELFORD AND WREKIN COUNCIL
A41 A518 (NEWPORT) (40MPH AND DE-RESTRICTED SPEED LIMIT)
ORDER 2019

Notice is hereby given that Borough of Telford & Wrekin has made the above named Order under Sections 82, 83 and 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The order will come into effect on the 16th July 2021.

The effect of the Order revokes to the extent specified in Schedule One to this Order the existing De-Restricted speed limit shown in (The Trunk Road (A41 Newport By-Pass) (De-Restriction) Order 1984) and introduces a speed limit of 40mph along the lengths of roads specified in Schedule Two and a De-Restricted speed limit along the length of road specified in Schedule Three.:

Schedule One – Revocations

The Trunk Road (A41 Newport By-Pass) (De-Restriction) Order 1984	A41	From a point 100 metres north of the centre of the roundabout at the junction of the trunk road with the A518 to a point 100 metres south of the centre of that roundabout (a distance measured along the said length of road of approximately 200 metres)

Schedule Two – 40mph Speed Limit

1.	A41	From a point 350 metres north-west of its junction with the A518 in a south-easterly direction to a point 30 metres south-east of its junction with the A518.
2	A518.	From its junction with the A41 in a south-westerly direction to a point 30 metres south-west of its junction with Station Road
3	Audley Lane	From a point 30 metres north-west of its junction with the A518 in a south-easterly direction to a point 20 metres south east of its junction with the A518
4	Pave Lane	From its junction with A518 in a south-easterly direction for a distance of 50 metres.
5	Station Road	From its junction with the A518 in a north-westerly direction for a distance of 30 metres.

Schedule Three – De-Restricted

1.	A41	From a point 30 metres south-east of its junction with the A518 in a south-easterly direction to a point 75 metres south-east of its junction with the A518.
