

Telford & Wrekin Council (A4640, Donnington - Priorslee) (40mph, 50mph Speed Limits, Restricted Roads and Revocations) Order 2021

Notice is hereby given that Borough of Telford and Wrekin in exercise of their powers under Sections 82, 83 and 84, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby propose to make the following Order: Telford & Wrekin Council (A4640, Donnington - Priorslee) (40mph, 50mph Speed Limits, Restricted Roads and Revocations) Order 2021

When this Order comes into effect;

- The road specified in Schedule 1 to this Order shall be a Restricted Road for the purposes of Section 81 of the Road Traffic Regulation Act 1984.
 - No person shall drive any motor vehicle at a speed exceeding 40mph on the length of restricted road specified in the Schedule 2 to this Order.
 - No person shall drive any motor vehicle at a speed exceeding 50mph on the length of restricted road specified in the Schedule 3 to this Order.

Schedule 1	
Restricted Road	
1. Donnington Wood Roundabout, Donnington	It's gyratory for its entire length.
2. Granville Roundabout, Donnington	It's gyratory for its entire length.
Schedule 2	
40mph	
1. Castle Farm Way	From its junction with Limekiln Bank Roundabout in a southerly direction to a point 280 metres south-east of Ernest Dawes Avenue (south-east junction).
2. Cloisters Way	From its junction with Redhill Way Roundabout in a westerly direction for a distance of 23 metres.
3. Priorslee Avenue	From its junction with Castle Farm Way in a westerly direction for a distance of 23 metres.
4. Redhill Way	From a point 20 metres north of its junction with Redhill Roundabout in a southerly direction to Limekiln Bank Roundabout.
5. Telford Way	From its junction with Limekiln Bank Roundabout in a westerly direction for a distance of 156 metres.
6. Donnington Wood Way	From a point 19 metres north of its junction with Granville Roundabout in a north-easterly direction to a point 15 metres south-west of its junction with Donnington Wood Roundabout.
Schedule 3	
50mph	
1. Donnington Wood Way	A4640 from a point 720 metres south-east of the Donnington (Clock Tower) Roundabout to a point 25 metres north-west Donnington Wood Roundabout.
2. Redhill Way	From a point 20 metres north-west of its junction with Redhill Roundabout to a point 10 metres south-east of it junction with Granville Roundabout.
