

Telford & Wrekin Council (A518, Newport, Chetwynd Aston Area) (40MPH Speed Limit) Consolidation Order 2021

Notice is hereby given that Borough of Telford & Wrekin HAS MADE the above named Consolidation Order under Sections 82, 83 and 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The Consolidation Order will come into effect on 25th day of October 2021. The effect of the Order is to revoke the provisions of various existing Orders in Schedule 2 to this Order affecting parts of roads within the Borough of Telford and Wrekin and those provisions be re-enacted the 40mph speed limit along the following lengths of roads described in the Schedule 1 to this Order.

Any persons wishing to question the validity of the Consolidation Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirements of the Act or of any instrument made under the Act have not been complied with, that person may within 6 weeks from the date on which the Consolidation Order is made, apply for that purpose to the High Court.

| 6) LITTLEHALES ROAD, CHETWYND ASTON | From its junction with Pave Lane in a southerly direction for a distance of 145 metres. |
| 7) PAVE LANE | From its junction with A518 in a south-westerly direction for a distance of 50 metres. |
| 8) PAVE LANE, CHETWYND ASTON | from a point 38.5 metres west of its junction with A41 to a point 50 metres south-east of its junction with A518 |
| 9) PITCHCROFT LANE | From its junction with Pave Lane in a south-westerly direction for a distance of 212.5 metres. |
| 10) STATION ROAD | From its junction with A518 in a north-westerly direction for a distance of 30 metres. |
| 11) STATION ROAD, NEWPORT | That length of Station Road which extends 30 metres north-west from its junction with the A518 for a distance of 230 metres in a north westerly direction |

1) WELLINGTON ROAD, NEWPORT. That length of Wellington Road from a point 96 metres south of the southern end of its junction with Dark Lane for a distance of 1085 metres in a southerly direction to its junction with the A518 at Pitchcroft Roundabout.

1) STATION ROAD, NEWPORT. That length of Station Road which extends 30 metres north-west from its junction with the A518 for a distance of 230 metres in a north westerly direction

- PAVE LANE, CHETWYND ASTON. From a point 38.5 metres west of its junction with A41 to a point 50 metres south-east of its junction with A518
- FIELD ASTON LANE, CHETWYND ASTON. From its junction with Pave Lane in an easterly direction for a distance of 297 metres.
- LITTLEHALES ROAD, CHETWYND ASTON. From its junction with Pave Lane in a southerly direction for a distance of 145 metres.
- PITCHCROFT LANE. From its junction with Pave Lane in a south-westerly direction for a distance of 212.5 metres.
- CHETWYND ASTON SPUR TURNING HEAD, CHETWYND ASTON. From its junction with Pave Lane in a north-westerly direction to its north-eastern extremity and approximate distance of 318 metres.

- AUDLEY AVENUE. From a point 30 metres north-west of its junction with A518 in a south-easterly direction to a point 20 metres south-east of its junction with A518.
- PAVE LANE. From its junction with A518 in a south-westerly direction for a distance of 50 metres.
- STATION ROAD. From its junction with A518 in a north-westerly direction for a distance of 30 metres.
