Partnership Team Roles & Responsibilities

Telford and Wrekin Safeguarding Partnership (TWSP) is responsible for making sure that children, young people and adults are kept safe in Telford and Wrekin.

TWSP is made up of three statutory partners - namely Telford & Wrekin Council, Telford & Wrekin Clinical Commissioning Group and West Mercia Police - as well as a wide range of other partners. Together, these organisations are responsible for making sure that children and adults of all ages and abilities get the help and protection that they need within Telford and Wrekin.

The TWSP is supported by the Partnership Team based at Telford and Wrekin Council who act as a central contact point between the different organisations. They are responsible for coordinating multi agency reviews and meetings concerning both children and adults cases with the aim of identifying future learning, training and areas of focus to protect vulnerable groups from abuse and neglect. Level 2 - Protect - CAUTION - RECOMMEND TO SEEK CONSENT PRIOR TO SHARING

- Could substantially distress individuals - Betray third party confidence - Breach statutory restrictions - Cause moderate financial loss - Facilitate improper gain - Prejudice investigation or facilitate crime - Disadvantage government

Level 3 - Restricted - SENSITIVE INFORMATION - YOU DO NOT HAVE PERMISSION

TO SHARE - Could cause significant financial loss - Facilitate improper gain - Prejudice investigation or facilitate crime - Disadvantage government - Impede the development or operation of government policies - Undermine public sector management or operations

Modern slavery offences sentencing guidelines published

The Sentencing Council has published the first sentencing guidelines for offenders convicted of Modern Slavery offences including slavery, forced labour, human trafficking or an offence committed to facilitate human trafficking.

The new guidelines, which were developed following consultation and come into effect on 1 October 2021, will give judges and magistrates dedicated guidelines to follow when sentencing offenders guilty of offences under the Modern Slavery Act 2015. They apply to England and Wales.

Telford and Wrekin Safeguarding Partnership Seminar/workshop(s)

TWSP have started organising a range of online seminars, focussing on a different theme each time. These seminars/workshops are available to all and are free. The next session takes place on 19th November between 1pm and 3pm. The workshop will be delivered by a guest speaker from the Disclosure and Barring Service – Cathy Taylor and will take place during Adult Safeguarding Week (15th – 21st November). The workshop will cover the following areas:

- The role of the disclosure and barring service
- Understanding DBS checks and role eligibility including levels of checks and the workforce
- Understand when an employee/volunteer is eligible for a check
- Understand the DBS Update Service
- How regulated activity is defined and what this means in practice
- Understand what safe recruitment practices can be in place and how DBS checks can form a part of this.
- The three different referral routes
- When a DBS Barring referral should be made, including when the legal duty is met
- How regulated activity is defined and what this means in practice
- How to make a good quality referral
- Provide a clear understanding of the consequences of not making appropriate barring referrals and the consequences of being included in one or both Barred Lists

Attendance at these free sessions will count towards your continuous professional development. We look forward to meeting you all and hope that you find the workshop informative.

Masterclass: Therapeutic Interventions to Reduce the Harmful Effects of Adverse Childhood Experiences

THURSDAY 21st OCTOBER 2021 - VIRTUAL, Online

This CPD certified programme will outline the increasing evidence of the impact of Adverse Experiences of Childhood (ACEs) on the health and well-being of children and young people extending into adult life. There is a growing demand for interventions to prevent their harmful effects.

Research will be reviewed about the impact of ACEs through population studies, intergenerational studies, and specific groups – self harming, mental health, and substance abuse, offending, and violent behaviour.

Approaches to intervention will be reviewed, to prevent the harmful impact of maltreatment and the limitations of these approaches to fit with the complex responses associated with multiple ACEs.

Facilitated by: Arnon Bentovim trained at the Maudsley Hospital/Institute of psychiatry trained as a Psychoanalyst, and subsequently became involved in the growing interest in the systemic/family therapy field. He helped to establish the Association and Institute of Family Therapy, and researched measures of family functioning, and clinical approaches with colleagues at the Institute of Child Health and Great Ormond Street Children's hospital.
