 Helens, Halton, Knowsley, Sefton, Bristol, South Gloucestershire, Bath, North East
 Somerset, West Midland, London, West Yorkshire, Sheffield)
- Learners must have been a resident in the UK for at least 3 years, and be able to provide proof of ID / residency
- Learners can access the qualifications regardless of their employment status & earnings. They will be asked to provide proof of benefit or earnings as part of the enrolment process and AEB funding requirements.
