Telford & Wrekin Council (Haygate Road, Wellington) (Prohibition of Waiting and Limited Parking) Traffic Regulation Order 2022

Notice is hereby given that the Borough of Telford & Wrekin in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby propose to make the following Order.

- When this Order comes into effect;
 - (a) The Orders specified in the Schedule of Revocation of this Order shall have the effect of revoking the item specified in that schedule.
 - (b) Waiting will be prohibited at all times on the roads specified in Schedule 1 of this Order to the extent specified.
 - (c) Waiting will be restricted between the hours of 8am and 6pm on Monday to Saturday inclusive on the roads specified in Schedule 2 of this Order to the extent specified.
 - i. For a longer period than 1 hour; or
 - ii. If a period of less than 1 hour has elapsed since the termination of the last period of waiting by that vehicle.
