

## TELFORD & WREKIN COUNCIL (IRONBRIDGE, TELFORD AND NEWPORT) (OFF-STREET PARKING PLACES) VARIATION OF CHARGES NOTICE 2022

Telford & Wrekin Council ("the Council") in exercise of its powers to issue a NOTICE OF VARIATION is given in accordance with the Section 35C of the Road Traffic Regulation Act 1984 as amended and by the virtue of Regulation 25 of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996. No provisions of this Notice shall come into effect before the end of a period of 21 days beginning from the date of this Notice. Specifies in Column 1 of Schedule 1 of this Notice are the car parks affected by the variation of charges, Column 2 specifies the parking period times and Column 3 shows the current rates of charges and Column 4 shows the new rates for parking in respect of the car parks mentioned in Columns 1.

This Notice comes into force on **4<sup>th</sup>** day of **April 2022**. For those charges that are being increased, the existing and new charges are set out below:
