

TELFORD & WREKIN COUNCIL (HADLEY, TELFORD) (PROHIBITION OF WAITING AND DISABLED BAY) TRAFFIC REGULATION ORDER 2022

Notice is hereby given that Borough of Telford and Wrekin in exercise of its powers Has Made an Order under Sections 1(1), 2(1), 2(2), 4(2), 32, 35 and Part III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act.

This Order will come into operation on Monday 06 day of April 2022

1. When this Order comes into effect; waiting will be prohibited at all times on the following length(s) of road(s) specified in the Schedule 1 below.
2. To provide Disabled parking bays operating at all times on the following length (s) of road (s) specified in the Schedule 2 below.
3. The prohibitions and restrictions on the following length(s) of road(s) listed under the Order titles specified in the Schedule of Revocations are hereby revoke.
4. A copy of the made Order, the relevant plans, a statement of the Council’s reasons for proposing to make the Order, may be examined online at www.telford.gov.uk/tro
5. Any persons wishing to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirements of the Act or of any instrument made under the Act have not been complied with, that person may within 6 weeks from the date on which the Order is made, apply for that purpose to the High Court.

Schedule 1 (No waiting at any time)	
Column 1	Column 2
1. Crescent Road, Telford And Wrekin (the north side)	From its junction with the centre line of Manse Road in a westerly direction for a distance of 133 metres. From its junction with Manse Road in an easterly direction for a distance of 10 metres.
2. Crescent Road, Telford And Wrekin (the north-west side)	From a point 22 metres south-west of the junction with the centreline of Mafeking Road in a north-easterly direction for a distance of 208 metres.
3. Crescent Road, Telford And Wrekin (the south side)	From a point 14 metres east of the centre of the junction with Manse Road in an easterly direction for a distance of 37 metres.
4. Crescent Road, Telford And Wrekin (the south-east side)	From a point 22 metres south-west of its junction with the centreline of Mafeking Road in a north-easterly direction for a distance of 33 metres.
5. Mafeking Road, Telford And Wrekin (the north-east side)	From the junction with Crescent Road in a north-westerly direction for a distance of 24 metres.
6. Mafeking Road, Telford And Wrekin (the south-west side)	From the junction with Crescent Road in a north-westerly direction for a distance of 24 metres.
7. Manse Road, Telford And Wrekin (the east side)	From its junction with Crescent Road in a northerly direction for a distance of 112 metres.



8. Manse Road, Telford And Wrekin (the west side)	From its junction with Crescent Road in a northerly direction for a distance of 11 metres.

Column 1	Column 2
1. Crescent Road, Telford And Wrekin (the south side)	From a point opposite the prolongation of the western building line of No.44 in an easterly direction for a distance of 6.6 metres.
2. Crescent Road, Telford And Wrekin (the south-west side)	From a prolongation of the property line of No.64 & 66 in a south-westerly direction for a distance of 6.6 metres.
3. Manse Road, Telford And Wrekin (the west side)	From a 23 metres north of its junction Crescent Road (outside no.38) in a northerly direction for a distance of 6.6 metres.

Items to be revoked from:

(VARIOUS ROADS, HADLEY & LEEGOMERY, TELFORD) (PROHIBITION & RESTRICTION OF WAITING & RESTRICTION OF STOPPING) ORDER 2013

No waiting at any time

- (i) Crescent Road, both sides, from a point approximately 23m north-east of its junction with Mafeking Road for a distance of approximately 45m in a south-westerly direction.
- (ii) Crescent Road, both sides, for the entire length of the turning head area up to the westerly building line of property 68
- (iii) Mafeking Road, both sides, from its junction with Crescent Road in a north-westerly direction for a distance of approximately 24m in a north-westerly direction

No Waiting - Part Time 2 Mon-Fri 8am-9.30am and 2.30pm-4pm

- (i) Crescent Road, both sides, for the entire length of the turning head area up to the westerly building line of property number 54.

No Stopping - School Keep Clear Mon-Fri 8am-5pm

- (i) Crescent Road, the south side, From a point approximately 37m west of the centreline of Manse Road for a distance of approximately 26m in a westerly direction.
- (ii) Crescent Road, the south side, From a point approximately 8m west of the centreline of Manse Road for a distance of approximately 26m in a easterly direction.

Items to be revoked from:

TELFORD & WREKIN COUNCIL (VARIOUS ROADS, HADLEY, HORTONWOOD, APLEY & LILLESHELL, TELFORD) (PROHIBITION OF WAITING) ORDER 2019

No waiting at any time

- (i) Crescent Road, the south side, From a point 48m east of the centreline of Manse Road in a westerly direction to a point opposite the westerly building line of property No.54.
- (ii) Manse Road, both sides, From its junction with Crescent Road in a northerly direction for a distance of 10m

This permanent Order will replace the previous experimental Order. There are no unresolved objections and the Council is satisfied that the restriction should remain in place, to restrict parking so to maintain the free flow of traffic on the lengths of roads affected by this Order.
