# MODIFICATION ORDER HAYGATE ROAD [FOOTPATH 13 (PART)], DIVERSION ORDER 2022 (WELLINGTON PARISH COUNCIL)

The above Order, made on 25 August 2022, if confirmed as made will modify the Definitive Map and Statement for the area by diverting the footpath from SJ 64196 11371 at the junction with Footpath 14 and Footpath 16 the route being an undefined path having a width of 1 metre continues north-west for a distance of 45 metres to SJ 64172 11413 then continues west-by-south for a distance of 122 metres to SJ 64046 11382 then continues south-west-by-west for a distance of 63 metres to SJ 64016 11344 then continues west for a distance of 112 metres to SJ 63886 11337 at the boundary of the development site, to SJ 64196 11371 at the junction with Footpath 14 and Footpath 16 the route being a surfaced path having a width of 2 metres continues west for a distance of 25 metres crossing the Estate Road at SJ 64044 11358 then continues west for a distance of 100 metres to SJ 63970 11351 where the path does a short dog-leg before continuing west to a further 55 metres to SJ 63886 11337 at the boundary of the development site as shown on the Order Plan.
