## Telford and Wrekin Council Off-Street Parking Places - Southwater Multi-Storey Car Park Order 2022

**Notice is hereby given** that Borough of Telford & Wrekin in exercise of its powers Has Made an Order under Sections 32, 33, 35, 35A, 124 and Part III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act.

- 1. The parking places subject to this Order are all in Telford Town Centre at Southwater Multi-Storey ("the Parking Places").
- 2. Telford and Wrekin Council Off-Street Parking Places Order 2018 Southwater Multi-Storey Car Park will be revoke in its entirety.
- 3. This Order shall come into force on 07<sup>th</sup> day of November 2022, introduce arrangements for use of the Parking Place, introduce Initial Charges, maximum permitted parking periods and introduce Penalty Charges for contravention of this Order.
- 4. This order shall introduce arrangements for use of the Parking Places, introduce maximum permitted parking periods and introduce excess charges for contravention of this Order.
- 5. From Monday to Saturday inclusive between 8am and 7pm of the initial charges in respect of a Vehicle or Trailer parked on the Parking Place at Southwater Multi-storey car park are as follows:

| Time period   | Tariff | Time period   | Tariff |

| Up to 2 hours | £1.60  | Up to 5 hours | £4.00  |

- 6. From Monday to Saturday inclusive between 5pm to 8am the following morning of the initial charges in respect of a Vehicle or Trailer parked on the Parking Place at Southwater Multi-storey car park is £1.00.
- 7. On Sundays between 8am to 5pm of the initial charges in respect of a Vehicle or Trailer parked on the Parking Place at Southwater Multi-storey car park is £1.00.
- 8. Season Ticket charges in respect of a Vehicle or Trailer parked on the Parking Place at Southwater Multistorey car park are as follows:
