NOTICE OF SPEED LIMIT PROPOSAL

Telford & Wrekin Council (Church Hill, Dawley Road and New Works Lane, Telford) (30mph, 40mph, 50mph Speed Limit, Restricted Road and Revocation) Order 2022

Notice is hereby given that Borough of Telford & Wrekin are proposing to make the above named Order under Sections 82, 83 and 84, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

The effect of the Order will be to revert the section of road listed in Schedule 1 to a Restricted Road for the purpose of Section 81 of the Act. To introduce a speed limit of 30mph and amend both the existing 40mph and 50mph speed limits along the following lengths of roads listed within Schedules 2, 3 and 4 below and to revoke previous Orders listed within Schedule 5 to this Order and are shown below:

to introduce a reduction to the speed limit of a de-restricted road to a 30mph speed limit. In addition, update and redefine both the existing speed limit of 40mph and 50mph on Dawley Road to also include a 55 metres section of New Works Lane.
