

TELFORD & WREKIN COUNCIL (PRIORSLEE AREA, TELFORD) (PROHIBITIONS, RESTRICTIONS OF WAITING, LIMITED WAITING AND LOADING BAYS) TRAFFIC REGULATION ORDER 2023

NOTICE IS HEREBY GIVEN that the Borough of Telford & Wrekin (hereinafter referred to as “the Council”) in exercise of its powers proposed to make an Order under Sections 1(1), 2(1), 2(2), 4(1), 4(2), 32, 35 and Part III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby propose to make the following Order.

The effect of the Order will be to introduce a prohibition of driving of motor vehicles the following lengths of roads described in the Schedule to this order.

The effect of the Order will be: -

- a) To amend and introduce double yellow lines (mainly junction protection) that will prohibit vehicles from waiting ‘At any time’ in part(s) of the following length(s) of road(s): - Access Road (north–west of Priors Gate), Bayswater Close, Brookvale Road, Cadman Drive, Chancery Park, Church Street (between Gower St and Park Close), Colliford Close, Coniston Drive, Cooper Close, Derwent Drive, Duke Street, Everglade Road, Ferndale Drive, Gatcombe Way (between Castle Farm Way and Westminster Way), Glen Brook Road, Gough Close, Hazel Way, Highgate Drive, Highgrove Meadows, Holborn Crescent, Kesworth Drive, Lambeth Drive, Mayfair Grove, Park Close, Pitchford Drive, Priors Gate, Priorslee Avenue (between Priorslee Village and Glen Brook Road), Priorslee Village, West Street (between Gower Street and Hill Street), Westminster Way and Wyndham Grove.
- b) To introduce single yellow line that will restrict waiting of vehicles from Waiting ‘8am to 9am & 3pm – 4pm Monday to Friday’ inclusive in part(s) the following length(s) of road(s): - Cadman Drive, Cooper Close, Gough Close and Pitchford Drive.
- c) To provide a 1 hour, No return within 1 hour Limited Waiting bay operating 7am to 7pm on all days in the following length of road: - West Street - south side; 16 metres west of Stafford Street in a westerly direction for 14 metres.
- d) To provide a 30 minute, No return within 1 hour Loading Only bays operating 7am to 7pm on all days in the following length of road: - West Street - south side; 13 metres west of Grove Street in a westerly direction for 13 metres.
- e) To revoke existing prohibitions and restrictions on the length(s) of road(s) affected by this Order.
