

**TELFORD & WREKIN COUNCIL (DOSELEY AREA, TELFORD) (ENVIRONMENTAL WEIGHT LIMIT 7.5 TONNES – ACCEPT FOR ACCESS) TRAFFIC REGULATION ORDER 2023**

Notice is hereby given that Borough of Telford & Wrekin propose to make an Order under Sections 1(1), 2(1), 2(2), and 2(4) of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order will be to prohibit access to goods vehicles exceeding 7.5 Tonnes from travelling along the following length(s) of road(s) listed in the Schedule One to the Order as shown below. Orders and Items listed in Schedule two to the Order shall be revoked.
