

Telford & Wrekin Council (Great Dawley Area, Telford) (Prohibitions, Restrictions of Waiting and Verge/Footway Parking Prohibition Area) Traffic Regulation Order 2023

BOROUGH OF TELFORD & WREKIN in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III & IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby makes the following Order:-

1. This Order shall come into operation on the ## day of ##### 2023, and may be cited as the Telford & Wrekin Council (Great Dawley Area, Telford) (Prohibitions, Restrictions of Waiting and Verge/Footway Parking Prohibition Area) Traffic Regulation Order 2023.
2. The Orders specified in Schedule of Revocation of this Order shall be varied as set out in that Schedule. (Delete if no revocations are required)
3. (1) In this Order:-
 - "Authorised Parking Place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;
 - "Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 2000.
 - "Parking Disc" means a disc issued by a local authority, capable of showing the quarter hour period during which a period of waiting begins.
- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (a) A Disabled Person's Badge in the relevant position, when:-
 - (i) In the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and
 - (b) a Parking Disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.
- (3) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
4. (1) Nothing in Article 7 and 8 shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of roads specified in Schedule 2 and 3 to this order for so long as may be necessary to enable:-
 - (a) persons to board or alight from a vehicle;

- (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
 - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
 - (c) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
 - (d) a vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
 - (e) a vehicle to wait at or near to any premises situated on or adjacent to the sides of lengths of roads for so long as such waiting is reasonably necessary in connection with any wedding or funeral; or
 - (f) the vehicle to be used for Fire Brigade, Ambulance or Police purposes.
- (2) Nothing in Article 7 and 8 to this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded onto or unloaded from the vehicle on the sides of lengths of roads specified in the Schedule 2 and 3 to this Order, at any time.
- (3) Nothing in Article 6, 7 and 8 to this Order shall render it unlawful to cause or permit any vehicle:
- (a) to wait upon an Authorised Parking Place
- (4) Nothing in Articles 6, 7 and 8 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a Parking Disc (on which the driver, or person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on any of the sides of lengths of roads referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment

6. Subject to the provisions of this Order, each length(s) of road(s) specified in column 2 of Schedule 1 shall be part of a Verge/Footway Parking Prohibition area and save as provided in Article 4 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or where the council has installed an Authorised Parking Place, cause or permit any vehicle to wait at any time either partly or wholly on a footway or verge adjacent to the length(s) of road(s) specified in Schedule 1 of this Order.
7. Save as provided in Article 4 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time on the sides of the lengths of roads specified in Schedule 2 of this Order.
8. No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between 8am to 9am and 2.30pm to 3.30pm from Monday to Friday inclusive on the length(s) of road(s) specified in Schedule 3 of this Order unless.

27. Heath Hill, Telford And Wrekin (the south side)	From a point 128 metres south-west of its junction with Heath Hill in a southerly direction including the hammer head to its southern extent.
28. Heath Hill Industrial Estate, Telford And Wrekin (the east side)	From a point 128 metres south-west of its junction with Heath Hill in a southerly direction to its southern extent.
29. King Street, Telford And Wrekin (the north-east side)	From a point 12 metres north-east of the centreline of the junction for Lancaster Avenue in a south-westerly direction for a distance of 20 metres.
30. Lancaster Avenue, Telford And Wrekin (the north side)	From its junction with King Street in a south-easterly direction for a distance of 82 metres. From a point 13 metres north-west of the centreline for the junction of Lancaster Court in a south-easterly direction for a distance of 26 metres.
31. Lancaster Avenue, Telford And Wrekin (the south side)	From its junction with King Street in a south-easterly direction for a distance of 71.5 metres.
32. Lancaster Court, Telford And Wrekin (the east side)	From its junction with Lancaster Avenue in a southerly direction for a distance of 10 metres.

43. Manor Road, Telford And Wrekin (the north-west side)	From its junction with Harp Lane in a westerly direction for a distance of 10 metres.

45. Old Vicarage Road, Telford And Wrekin (the south-west side)	From the centreline for the junction of Manor Road in a southerly direction for a distance of 13 metres.
46. Pool Hill, Telford And Wrekin (the north-west side)	From its junction with Webb Crescent in a south-westerly direction following the kerb alignment and then heading in a north-westerly direction for a distance of 66 metres.

47. Pool Hill, Telford And Wrekin (the south-east side)	From its junction with Webb Crescent in a south-westerly direction to its south-western extent, including the turning head.
48. Pool Hill, Telford And Wrekin (the west side)	From the south-westerly extremity in a northerly direction following the kerb alignment then in a north-westerly direction for a distance of 79 metres.
49. Rhodes Avenue, Telford And Wrekin (the north side)	From its junction with Alma Avenue in an easterly direction for a distance of 13 metres. From a point 6 metres west of the junction for the Mini Roundabout for Rhodes Avenue in an easterly direction for 24 metres.
50. Rhodes Avenue, Telford And Wrekin (the south side)	From a point 6 metres west of the junction for the Mini Roundabout on Avenue in an easterly direction for 24 metres.
51. Rhodes Avenue, Telford And Wrekin (the south-east side)	From its junction with Alma Avenue in an easterly direction for a distance of 10.5 metres. From a point 4 metres south-east of the junction for the Mini Roundabout for Rhodes Avenue in a northerly direction for 16 metres.
