

## **Telford & Wrekin Council (Great Dawley Area, Telford) (Prohibitions, Restrictions of Waiting and Verge/Footway Parking Prohibition Area) Traffic Regulation Order 2023**

**NOTICE IS HEREBY GIVEN** that the Borough of Telford & Wrekin (hereinafter referred to as “the Council”) proposed to make an Order under 1(1), 2(1), 2(2), 4(2), Part III & IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby makes the following Order:-

All prohibitions, restrictions and provisions apply to the roads in Great Dawley Area of Telford & Wrekin and the effect of the Order will be: -

- 1) To prohibit motor vehicles waiting on the footway and verge at all times on all days on the following road(s):-
  - Anselm Court, Aylwin Court, Cadfael Drive, Edit Close, Ellis Peters Drive, Ellis Peters Drive (Cul-de-sac) and Pargeter Close.
- 2) To prohibit waiting at any time (double yellow lines) in parts of the following roads: -
  - Alma Avenue, Anselm Court, Aylwin Court, Cadfael Drive, Crown Street, Crown Street (Cul-de-sacs), Edith Close, Ellis Peters Drive, Ellis Peters Drive (Cul-de-sac), Harp Lane, Heath Hill Industrial Estate, King Street, Lancaster Avenue, Lancaster Court, Lancaster Place, Langley Crescent, Langley Fold, Manor Gardens, Manor Road, Old Vicarage Road, Pool Hill, Rhodes Avenue, Southall Road, St Leonard’s Place and Worcester Road.
- 3) To restrict waiting (single yellow line) operating from 8am to 9 am and 2.30pm to 3.30pm Monday to Friday inclusive the following length(s) of road;
  - **1)** Ellis Peters Drive, north-east side; 8 metres west of the prolongation of the western kerbline of Ellis Peters Drive in an easterly direction for 20 metres. **2)** 10 metres north-west of the prolongation of the centreline of Anselm Court in a south-easterly direction for 20 metres.

4) To revoke certain existing prohibitions and restrictions from the following Orders: - ;
