

## Telford & Wrekin Council (Various Streets, Lawley) (Restricted Parking Zone, Waiting Restrictions and Parking Provisions) Traffic Regulation Order 2023

The Council gives notice that it proposes to make the following Traffic Order. All prohibitions, restrictions and provisions apply to the roads in Lawley Area (Telford & Wrekin) and the general effects of the Order are to:-

- 1) To introduce a Restricted Parking Zone (RPZ) where Waiting is prohibited at all times on all days in the Birchfield Way RPZ that includes the following Length(s) of Road(s): - Birchfield Way (35 metres south of Hobbins to a point 50 metres north of Miriam Lane) and Tuold Mews (from Birchfield way to the western property line on No.5 &12).
- 2) To introduce a Restricted Parking Zone (RPZ) where Waiting and Loading is prohibited at all times on all days in the Lawley Square RPZ that includes the following Length(s) of Road(s): - Arleston Lane (From Lawley Drive in a north-westerly direction for 68 metres); Birchfield Way (From West Centre Way to a point 35 metres south of Hobbins Lane); Bryce Way (From West Centre Way in a south-westerly direction for 140 metres); Cadman Court and Gresham Drive (From West Centre Way in a northerly direction for 103 metres); Hunters Rise (From West Centre Way in a southerly direction for 43 metres); Lawley Drive (100 metres south-west of Arleston Lane/West Centre Way in a northerly direction for 230 metres) and West Centre Way (From Lawley Drive to a point 50 metres north-east of Gresham Drive).
- 3) To prohibit waiting at any time on in the following roads; Arleston Lane, Bank Road, Bartholomew Road, Cemetery Road, Church Croft, Clips Moor, Dawley Road, Glendale, Highfield Hunters Rise Lilac Meadows, Park Road, The Meadows and Village Drive.
- 4) To provide a Limited Waiting parking places operating 8am to 6pm from Monday to Saturday inclusive for 30 minutes parking with a No Return to the same parking place within 3 hours in the following length of road; **1)** Birchfield Way, north-east side; from the prolongation of the northern building line of unit 13 Birchfield Way in a southerly direction for 11 metres. **2)** The lay-by located 20 metres north-west of West Centre Way in a north-westerly direction for 30 metres. **3)** South-west side; the lay-by 35.5 metres north-west of West Centre Way in a north-westerly direction for 17.5 metres.
- 5) To provide a Loading Only parking places operating 8am to 6pm from Monday to Saturday inclusive for 30 minutes parking with a No Return to the same parking place within 3 hours in the following length of road; **1)** Birchfield Way, north-east side; from a point 11 metres south-east of the prolongation of the northern building line of unit 13 Birchfield Way in a southerly direction for 15 metres. **2)** The lay-by located 18 metres north-west of West Centre Way in a north-westerly direction for 17.5 metres.
- 6) To provide General Parking Places operating Midnight to 8am and from 6pm to Midnight on Monday to Saturday inclusive and Sunday 'At all times' in the following length of road; **1)** Birchfield Way, north-east side; from a point 11 metres south-east of the prolongation of the northern building line of unit 13 Birchfield Way in a southerly direction for 15 metres. **2)** From the prolongation of the northern building line of unit 13 Birchfield Way in a southerly direction for 11 metres. **3)** The lay-by located 20 metres north-west of West Centre Way in a north-westerly direction for 30 metres. **4)** Birchfield Way, south-west side; the Lay-by at a point 18 metres north-west of West Centre Way in a north-westerly direction for 17.5 metres. **5)** The Lay-by at a point 35.5 metres north-west of its junction with West Centre Way in a north-westerly direction for 17.5 metres
- 7) To provide General Parking Places operating 'At all times on all days' in the following length of road; **1)** Birchfield Way, South-east side; The lay-by located 27 metres south-west of the B5072 West Centre Way in a south-westerly direction for 20 metres. **2)** The lay-by located 57 metres south-west of the B5072 West Centre Way in a south-westerly direction for 19.5 metres. **3)** The lay-by located 92 metres south-west of the B5072 West Centre Way in a south-westerly direction for 20 metres. **4)** The lay-by located 117.5 metres south-west of the B5072 West Centre Way in a south-westerly direction for 22 metres.
- 8) To revoke certain existing prohibitions and restrictions from the following Orders;

The purpose of the proposed Order is to improve the free flow of traffic by removing indiscriminate parking on the public highway and improving safety for pedestrian on the footway affected by this Order.
