TWC/2023/0212 – 212 The Tuckies, Salthouse Road, Jackfield – Replacement of pitched roof with a flat roof and roof lantern and removal of 2no. windows and 1no. door and installation of 2no French doors to side elevation. Reinstate 1no. ground floor window and 1no. first floor window to front elevation. Replacement of glass roof with a tiled roof and installation of 6no. roof lights, replacement of 1no.window and 1no. door to 2no. windows and 1no. door to conservatory link. Part conversion of double garage into a habitable room including removal of 3no. roof lights and installation of 5no. roof lights, installation of 1no window and replacement of garage door
