The above Order, made on 12 April 2023, under Section 119 of the Highways Act 1980, and Section 53(2)(b) of the Wildlife and Countryside Act 1981, if confirmed as made will modify the definitive map and statement for the area by deleting the footpath From SJ 58839 15515 at the junction with Restricted Byway 4B the route being a field-boundary path having a width of 1.5 metres continues south for a distance of 65 metres to SJ 58853 15447 then continues south as a cross-field path having a width of 1 metre for a distance of 755 metres to SJ 58888 14698 adding a route From SJ 58747 15225 at the Junction with Rodenhurst Lane the route continues south-south-east as a field-edge path having a width of 2 metres for a distance of 340 metres to a kissing gate at SJ 58827 14897 then continues south-south-east as a field-edge path having a Width of 2 metres to SJ 58888 14698 Limitations: Kissing gate at SJ 58747 15225 and SJ 58827 14897.
