**NOTICE OF MODIFICATION ORDER**  
**SECTION 53 WILDLIFE AND COUNTRYSIDE ACT 1981**  
**FOOTPATH 17B (PART) DELETION AND ADDITION BARRACK LANE**  
**(PARISH OF LILLESHELL) 2023**

The above Order, made on 5 July 2023, if confirmed as made will modify the definitive map and statement for the area by removing a footpath from Ordnance Survey Grid Reference (OSGR) SJ 73426 16322 at the junction with Limekiln Woods in Lilleshall the route being an undefined path having no defined width continues south-south-east through a farm and an adjoining yard for a distance of 75 metres to point B on the Plan at OSGR SJ 73478 16235 then continues south through the farm and adjoining builders yard for a distance of 75 metres to point C on the Plan OSGR SJ 73482 16164 near the northern end of the disused canal channel and adding a path from Point A on the plan OSGR SJ 76426 16322 at the junction with Limekiln Woods in Lilleshall the route being an undefined path having a minimum width of 1 metre continues south-east through a farm area following the eastern boundary of the historical site of a pre-existing canal for a distance of 55 metres to point B on the Plan OSGR SJ 63481 16271 then continues south following the eastern boundary of the historical site of the canal for a distance of 105 metres to point C on the Plan OSGR SJ 73482 16164 near the northern end of the disused canal channel.
