Footpath 208 Upgrade to Bridleway (Brick Kiln Way) Parish of The Gorge Modification Order 2023

Footpath 60 Upgrade to Bridleway (School Lane) Parish of The Gorge Modification Order 2023

Footpath 110 Upgrade to Bridleway and Addition of Bridleway (Lincoln Hill) Parish of The Gorge Modification Order 2023

Footpath 85 Upgrade to Bridleway (Orchard Lane to Woodlands Road) Parish of The Gorge Modification Order 2023

Addition of Footpath GG001 (Church Hill) Parish of The Gorge Modification Order 2023

The above Orders, made on 7th September 2023 under Section 53(2)(b) of the Wildlife and Countryside Act 1981, if confirmed as made, will modify the Definitive Map and Statement for the area by adding and upgrading to a bridleway the following public rights of way:

Footpath 208 Upgrade commences at Brick Kiln Bank at Ordnance Survey Grid Reference (OSGR) SJ 67972 05146 being a track with an earth surface with a width of approximately 2.5 metres in a general West-South-West direction for approximately 243 metres to terminate at the junction with Bridleway 38 at OSGR SJ 67757 05039

Footpath 60 Upgrade commences at School Lane Ordnance Survey Grid Reference (OSGR) SJ 66949 04934 on the Order Map being a stone/earth surface with an approximate width of 2 metres in a general easterly direction for approximately 466 metres where it joins an unnamed Bridleway at OSGR SJ 67393 04933

Footpath 110 Upgrade commencing at Ordnance Survey Grid Reference OSGR SJ 67337 04016 on Lincoln Hill running in a general North-West direction for approximately 185 metres on an earth surface past the cemetery to join Bridleway 114 at OSGR SJ 67224 04152 and **Addition of Bridleway** commencing at Ordnance Survey Grid Reference OSGR SJ 67224 04152 on the junction with Bridleway 114 the route travels South West for approximately 103 metres on an earth surface to terminate on Church Road at OSGR SJ 67157 04075

Footpath 85 Upgrade commences on Orchard Lane from Ordnance Survey Grid Reference (OSGR) SJ 67714 03835, the route is a track with a stone surface with a width of approximately 2.5 metres running in a general South-South-West direction for approximately 92 metres to OSGR SJ 67675 03761 next to a property called The Woodlands then it changes to a general South-West direction on an earth surface for approximately 145 metres to OSGR SJ 67567 03675 where it terminates on the adopted highway of Woodlands Road by Woodlands Grange

Footpath GG001 Addition commencing on Church Hill at Ordnance Survey Grid Reference (OSGR) SJ 67354 03474 the route continues down steps with a minimum width of 1.5 metres in a general south-west direction for approximately 12 metres to OSGR SJ 67347 03464, the route continues down steps with a minimum width of 1.5 metres in a general south-south-east direction for approximately 10 metres to terminate on High Street at OSGR SJ 67349 03454

If no representations or objections are duly made to the Orders, or any part of it, or if any so made are withdrawn, the Borough of Telford & Wrekin, instead of submitting the Orders to the Secretary of State for Environment, Food and Rural Affairs may itself confirm the Orders. If the Orders are submitted to the Secretary of State for Environment, Food and Rural Affairs, any representations or objections which have been duly made and not withdrawn will be sent with it.
