Every Member<sup>1</sup> is required to register and disclose certain interests and those of their Partner<sup>2</sup> where they are aware of the existence of such interests:-

<p><b>Employment, office, trade, profession or vocation</b> Any employment, office, trade, profession or vocation carried on for profit or gain by you or your partner</p>	<p>Fee-paid Medical Member of the first-tier Tribunal, Social Entitlement Chamber (Social Security &amp; Child Support). GP Appraiser. Occasional GP Locum sessions.</p>
<p><b>Sponsorship</b> Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period<sup>3</sup> in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>	
<p><b>Contracts</b> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest<sup>4</sup>) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p>	

1 "member" means a member of the authority and includes a co-opted member;  
 2 Partner includes your spouse, civil partner or person with whom you are living as if they were your spouse or civil partner  
 3 "relevant period" means the period of 12 months ending with the day on which you give a notification of its existence  
 4 "body in which the relevant person has a beneficial interest" means a firm in which you or your partner is a partner or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and "director" includes a member of the committee of management of an industrial and provident society.

<p><b>Land</b> Any beneficial interest in land<sup>5</sup> which is within the area of the Council.</p>	<p>The garden surrounding my private residence, 4 Maeson, Telford, TF6 6PF.</p>
<p><b>Licences</b> Any licence (alone or jointly with others) to occupy land in the area of the Council for a month or longer.</p>	
<p><b>Corporate tenancies</b> Any tenancy where (to your knowledge)— (a) the landlord is the Council ; and (b) the tenant is a body in which you or your partner has a beneficial interest.</p>	
<p><b>Securities</b> Any beneficial interest in securities<sup>6</sup> of a body where— (a) that body (to your knowledge) has a place of business or land in the area of the Council ; and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	

**NOTES ON SENSITIVE INTERESTS**

An interest is sensitive if you and the Monitoring Officer agree that its disclosure could lead to you, or a person connected with you, being subject to violence or intimidation. The nature of your sensitive interest will not appear in the published register of interests but it may be recorded that you have a sensitive interest.

*I understand that I must write to the Clerk of our Council and the Monitoring Officer to tell him about any disclosure of a disclosable pecuniary interest made at a meeting which is not already included above within 28 days of making the disclosure*

<sup>5</sup> "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

<sup>6</sup> "securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
