<p>Contracts Any contract made between the member or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director¹ or a body that such person has a beneficial interest in the securities of¹¹) and the Council - (a) under which goods or services are to be provided or works are to be executed; and (b) Which has not been fully discharged</p>	None	
<p>Land Any beneficial interest in land held by the member or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners which is within the area of the Council. 'Land' excludes and easement, servitude, interest or right in or over land which does not give the member or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners (alone or jointly with another) a right to occupy or to receive income.</p>	None Except home address	
<p>Licences Any licence (alone or jointly with others) held by the member or his/her spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners to occupy land in the area of the Council for a month or longer.</p>	None

<p>Securities Any beneficial interest held by the member or their spouse or civil partner or the person with whom the member is living as if they were spouses/civil partners in securities of a body where – (a) That body (to the member’s knowledge) has a place of business or land in the area of the Council; and (b) either- (i) The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) If the share capital of that body is of more than one class, the total nominal value of the shares in any one class in which the relevant person has a beneficial interest that exceeds one hundredth of the total issued share capital of that class</p>	None

<p>Any body of which the member is in a position of general control or management and to which they are appointed or nominated by the Council.</p>

<p>Any gifts or hospitality worth more than an estimated value of £50 which the member has received by virtue of their office.</p>	None
<p>NOTES ON SENSITIVE INTERESTS An interest is sensitive if you and the Monitoring Officer agree that its disclosure could lead to you, or a person connected with you, being subject to violence or intimidation. The Nature of your sensitive interest will not appear in the published register of interest but it may be recorded that you have a sensitive interest.</p>
