Statement of Reasons
TELFORD AND WREKIN COUNCIL
VARIOUS ROADS (EXPERIMENTAL PROHIBITION OF WAITING)
ORDER No.2 2016

The general effect of this Experimental Order will be to introduce No Waiting at any time restrictions at the following locations across the Borough;

Newtown and Dark Lane, Church Aston.

Concern has been expressed by the local councilor and residents about parked vehicles affecting visibility from Newtown into Dark Lane. The proposals to install an initial minimum length of junction restriction will allow the Council to determine whether or not this length of restriction will need to be extended in the future to satisfactorily resolve the problem.

Quarry Lane, Ketley.

The petrol station has raised concerns about tanker deliveries exiting from the petrol station site along a narrow section of Quarry Lane onto Mossey Green Way. This narrow section has parked vehicles on both sides of the lane for most of the day. The experimental restrictions will allow unrestricted exit from the petrol station for large vehicles and will allow the Council to assess the impact of the possible displacement of parked vehicles into the neighbouring residential area. Further parking restrictions may be necessary to control the impact of parking in the residential area.

Haygate Road, Wellington

Concern has been raised about parking on both sides of the road, outside the veterinary surgery. The impact and exact length of parking restriction required will need to be assessed before a permanent Order is made.

Albert Road, Wellington

An initial length of double yellow lines was introduced to prevent parking around the junction with King Street. This has been extended on the Northern Side by an additional 15m but may need to be extended after monitoring of the parking in the area.

Wellington Road and Pemberton Road, Admaston

The sports field entrance has been relocated and overflow parking is causing visibility problems along Wellington Road. Restrictions are being implemented to assess the exact length required around the new entrance point to improve visibility.

Stafford Park 2 and Stafford Park 7

Regular deliveries to businesses in Stafford Park 7 have had increasing difficulty in negotiating parked vehicles or trailer at the junction with Stafford Park 2, some of vehicles or trailers are left overnight. Waiting restrictions are proposed to try and address the current parking issues but the exact length required will be monitored and assessed before any decision is made to make the restrictions permanent.

Stone Chat Close, Apley

After several consultation exercises with residents in the area it was agreed that an extension of the existing double yellow lines in Stone Chat Close would be made to extend them along the whole length of the Close. Stone Chat Close suffers from over flow parking from visitors to the Princess Royal Hospital and by extending the restrictions it will allow the Council to monitor the effect of displaced parking into other residential areas before permanent restrictions are considered.

Milners Lane, Dawley Bank

Parking around the Bulls Head public house causes visibility issues at the junction with Station Road. Parking restrictions are proposed to improve visibility but may need to be extended after monitoring of the situation has taken place.

And to install no waiting restrictions (Monday to Friday 7.45 to 8.45am and 2.15 to 3.15pm) at the following location;

New Road, Wrockwardine Wood

The provision of a school crossing patrol outside Telford Priory School has raised some safety concerns about vehicles parking close to the patrol site. The restrictions will be assessed to determine the most appropriate length so the patrol can operate safely at these times, whilst still allowing parking for shops and local businesses in the area.

At all sites consideration will be given after a trial period as to whether or not the provisions of this Experimental Order should be made permanent. Currently at the end of the trial period, the Council intends to consider making an Order which will continue in force indefinitely having the same effect as the current Experimental Order.

The reasons for proposing to make the above order are;

1. To promote a free and safe flow of traffic.
2. To deter vehicles from parking in locations where they cause an obstruction, and to prevent the likelihood of danger arising from these obstructions.
3. Enable access to properties along the route.

ORDER No.2 2016

Borough of Telford & Wrekin (hereinafter referred to as "the Council") in exercise of their powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following order.

1. This Order may be cited as the Telford and Wrekin Council Various Roads (Experimental Prohibition of Waiting) Order No.2 2016 and shall come into operation on 14 October 2016 for a period not exceeding eighteen months.

2. (1) In this Order:-

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges For Motor Vehicles) Regulations 2000.

"parking disc" means a disc issued by a local authority, 125 millimetres square and coloured blue capable of showing the quarter hour period during which a period of waiting begins;

"vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along road whether by animal or mechanical power;

(2) For the purpose of this Order a vehicle shall be regarded as displaying:-

a) a disabled person's badge in the relevant position, when:-

(i). in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen, and

(ii). in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle, and

b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.

3. Save as provided in Article 5 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to park, stop or wait at any time on all days on the sides of the road specified in Column 1 Schedule 1 and along the lengths of those roads described in Column 2 Schedule 1.

4. Save as provided in Article 5 to this Order no person shall except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to park, stop or wait Monday to Friday from 7.45am to 8.45am and from 2.15pm to

3.15pm on the sides of the roads specified in Column 1 Schedule 2 and along the lengths of those roads described in Column 2 Schedule 2.

5. (1) Nothing in Article 3 and 4 shall render it unlawful to cause or permit any vehicle to park, stop or wait on the sides of lengths of roads referred to therein for so long as may be necessary to enable:-
- a) persons to board or alight from a vehicle;
 - b) for the purpose of enabling goods to be loaded onto or unloaded from a vehicle;
 - c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i). building, industrial or demolition operations;
 - (ii). the removal of any obstruction to traffic;
 - (iii). the maintenance, improvement or reconstruction of the said sides of lengths of roads; or
 - (iv). the laying, erection, alteration or repair in, or the land adjacent to, the sides of lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in the Telecommunications Act 1984.
 - d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or any other Authority in the pursuance of statutory powers or duties;
 - e) the vehicle, to be used for the purpose of delivering or collecting postal packets as defined in the Postal Services Act 2000;
 - f) the vehicle to be used for Fire Brigade, Ambulance or Police purposes.
- (2) Nothing in Article 3 and 4 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver, or person in charge of the vehicle, has marked the time at which the period of waiting began) to park, stop or wait on any of the sides of lengths of roads referred to in the schedule for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).
6. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.
6. The Assistant Director: Governance, Procurement & Commissioning for the Council, or a person authorised by that officer, may modify or suspend the operation of the Order or any provision of it if it appears to him essential –
- a) in the interests of the expeditious, convenient and safe movement of traffic,
 - b) in the interests of providing suitable and adequate on-street parking facilities, or
 - c) for preserving or improving the amenities of the area through which any road affected by the order runs.
