

Expressions of Interest

Reablement/Intermediate Care Beds – Pilot from December 2016 via PPA variation

Telford & Wrekin Council along with the Telford & Wrekin Clinical Commissioning Group (CCG) are seeking expressions of interest from care home providers to Provide reablement/intermediate care beds as an addition to the existing Pre-Placement Agreement dated 1st October 2016.

This bed capacity will be required across the Borough for:

- admission to hospital avoidance
- post hospital discharge rehabilitation
- assessment for patients with general and EMI nursing and residential needs

This provision will be for short term admissions to facilitate early discharge or transfers to other settings supported by community services and social care, where necessary.

The Council / CCG are looking to purchase from either one home or spread across a number of homes.

The bed/s will be purchased as a spot contract arrangement and contractually will sit within the home's current Pre Placement Agreement, with the necessary variations being made. For each placement made, an Individual Placement Agreement will be issued invoking the terms and conditions of the Pre Placement Agreement.

The Council, through its Rehabilitation and Reablement Team and/or the Hospital Team will identify and coordinate appropriate referrals. It is anticipated that each stay would be for no more than 2 weeks but up to a maximum of 6 weeks. This will be supported by an agreed exit strategy agreed by the Intermediate Care Multi Disciplinary Team (ICMDT). A working protocol will be developed with the interested home/s which will cover the referral and admissions process for this service.

The term of this agreement will be for the duration of the existing Pre-Placement Agreement, however this will be reviewed at the end of May 2017 and subsequent regular intervals to measure the effectiveness of the service.
