### **Adoption Statement**

In accordance with Regulation 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) this Adoption Statement hereby gives notice that on 11 January 2018 Telford & Wrekin Council adopted the Telford & Wrekin Local Plan.

The Telford & Wrekin Local Plan was the subject of an independent examination conducted by Mr Michael J Hetherington BSc (Hons) MA MRTPI MCIEEM, an Inspector appointed by the Secretary of State. In his report published in November 2017 the Inspector confirmed that subject to a number of main modifications the Plan was sound and recommended its adoption. The main modifications and a number of additional minor modifications have been included in the adopted Telford & Wrekin Local Plan document which now carries full weight in the consideration of planning applications and supersedes the Core Strategy (2007), the policies which were saved from the Wrekin Local Plan (2000), the Central Telford Area Action Plan (2011), the Shropshire and Telford & Wrekin Minerals Local Plan (2000) and the policies which were saved from the Shropshire and Telford & Wrekin Joint Structure Plan (2002).

Any such application should be made promptly and, in any event, must be made not later than the end of the period of six weeks starting with the date on which the Telford & Wrekin Local Plan was adopted which was 11 January 2018.
