TELFORD AND WREKIN COUNCIL EDGMOND VILLAGE (VARIOUS ROADS) (30MPH SPEED LIMIT) ORDER 2018

BOROUGH OF TELFORD AND WREKIN in exercise of their powers under Sections 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

This Order shall come into operation on the XXXX and may be cited as Telford and Wrekin Council Edgmond Village (various roads) (30mph speed limit) Order 2018.

- 1. The provisions of The County Council of Salop (Restricted Roads) (No2) Order 1961 specified in Schedule One of this Order are hereby revoked.
- 2. No person shall drive any motor vehicle at a speed exceeding 30mph on the lengths of the roads specified in Schedule Two to this Order and as shown for identification purposes only on the attached plan.
- 3. The provisions of Article 2 shall not apply to any vehicle on any occasion when it is being used for ambulance service, fire service, or police purposes if the observance of that provision would be likely to hinder the use of the vehicle for the purpose which it is being used on that occasion.
- 4. In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes into operation, the provisions of this Order shall prevail.
