⁴ "body in which the relevant person has a beneficial interest" means a firm in which you or your partner is a partner or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and "director" includes a member of the committee of management of an industrial and provident society;

NOTES ON SENSITIVE INTERESTS

An interest is sensitive if you and the Monitoring Officer agree that its disclosure could lead to you, or a person connected with you, being subject to violence or intimidation. The nature of your sensitive interest will not appear in the published register of interests but it may be recorded that you have a sensitive interest.

I understand that I must write to the Clerk and Monitoring Officer to tell them about any disclosure of a disclosable pecuniary interest made at a meeting which is not already included above within 28 days of making the disclosure.
