

Telford & Wrekin Council Off Street Parking Places Order 2018 – Southwater Multi-Storey Car Park

NOTICE is hereby given that Borough of Telford & Council known as Telford & Wrekin Council, in exercise of its enabling powers under the Road Traffic Regulation Act 1984, has made the Telford & Wrekin Council Off Street Parking Places Order 2018 – Southwater Multi-Storey Car Park.

The Order will provide a public parking place at Southwater Multi-storey Car Park.

1. This order will come into effect on Thursday 7th March 2019.

2. The order shall introduce arrangements for use of the Parking Places, introduce parking charges for use of the Parking Places, introduce parking permits and season tickets for use within the Parking Place and introduce excess charges for contravention of the Order.

3. Motor vehicles with a weight greater than 4.5 tonnes unladen and with a height exceeding 1.9 metres, except for a Public Service Vehicle and Emergency Vehicles, will be restricted from entering and using the Parking Place.

4. This order introduces the following parking charges for use of the specified Parking Places 24 hours a day on every day of the year:
