

**TELFORD & WREKIN COUNCIL(VARIOUS ROADS, WROCKWARDINE WOOD & TRENCH, TELFORD)
(PROHIBITION OF WAITING & RESTRICTION OF WAITING) ORDER 2019**

Notice is hereby given that the Borough of Telford and Wrekin in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III & IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby propose to make the following Order.

1. When this Order comes into effect;
 - (a) Waiting will be prohibited at all times on the length of roads specified in Schedule One of this Notice to the extent specified.
 - (b) Waiting will be prohibited between the hours of 7.45-9.15am & 2.15-3.45pm on Monday to Friday on the roads specified in Schedule Two of this Notice to the extent specified.
 - (c) The (Various Roads, Hortonwood, Trench & Wrockwardine Wood, Telford) (Revocation, Prohibition of Waiting & Restriction of Stopping) Order 2013 shall be varied as specified in the draft Order
2. A copy of the draft Order, the relevant plans, a statement of the Council's reasons for proposing to make the order, may be examined during usual office hours at Telford & Wrekin, Addenbrooke House, Ironmasters Way, Telford, TF3 4NT. Schedule One - (Prohibition of Waiting)

1. Church Road, Telford (the north-east side)	from a point 61 metres south-east of its Northern junction with Woodhouse Crescent in a southerly direction to its Southern junction with Woodhouse Crescent from its junction with Woodhouse Crescent in a south easterly direction to a point approximately 11 metres north-west of its junction with Malcolm Davies Drive
2. Dickins Road, Telford (both sides)	from its junction with Wade Road in a north-easterly direction for a distance of 10 metres
3. Gibbons Road, Telford (the north-east side)	from a point approximately 10 metres south-east of its junction with Dickins Road in a north-westerly direction for a distance of approximately 28 metres
4. Pickering Road, Telford (the north-west side)	from its junction with Church Road in a south-westerly direction to its junction with Richmond Avenue
5. Pickering Road, Telford (the south-east side)	from its junction with Church Road in a south-westerly direction to its junction with Richmond Avenue
6. Trench Road, Telford (the north-west side)	From a point approximately 41 metres south west of the centreline of Tudor Meadow in a south-westerly direction for a distance of approximately 65 metres

Schedule Two – (Restriction of Waiting) – Monday to Friday – 7.45 to 9.15am & 2.15 to 3.45pm

1. Gibbons Road, Telford (the north-east side)	from its junction with Wade Road in a north-westerly direction to a point 10 metres south-east of its junction with Dickins Road
2. Gibbons Road, Telford (the south-west side)	from its junction with Wade Road in a northerly direction for a distance of approximately 44 metres
3. New Road (North Of Wrockwardine Wood Way), Telford (the east side)	from the centreline of its junction with Chapel Terrace (No. 13-20) in a northerly direction for a distance of approximately 56 metres
4. New Road (North Of Wrockwardine Wood Way), Telford (the west side)	from its junction with the Leisure Centre entrance in a northerly direction for a distance of approximately 51 metres
5. Wade Road, Telford (the north-east side)	from a point 15 metres north-east of its junction with Church Road in a northerly direction from its junction with Gibbons Road
6. Wade Road, Telford (the west side)	from a point 15 metres north-east of its junction with Church Road in a northerly direction to its junction with Gibbons Road
