**Intro:** Les Sparks welcomed everyone to the meeting and introduced Paul Gossage, Director of Marketing at the Ironbridge Gorge Museum Trust, who is representing Anna Brennand.

## **World Heritage Site Management Plan**

The Management Plan has gone through several internal meetings at Telford & Wrekin Council and had subsequently been approved by Cabinet on 20 April along with the Telford & Wrekin Council Local Plan. Shropshire Council wish to formally approve the Plan but would not be able to do so until the September Cabinet meeting. Shropshire Council do not envisage making any changes to the Plan.

#### **Iron Bridge Conservation Project**

A commencement date has not yet been set due to the on-going procurement process. The procurement procedure has taken longer than anticipated and a contractor has not yet been appointed. The underwater inspection had been completed and no further deterioration to the foundations had been reported. The English Heritage Education Team continue to work on an educational programme and volunteer package and the Conservation in Action Team are working on a publicity campaign to encourage visitors to come and see the works. Talks are on-going with the utility companies.

## **Power Station**

No further information has been issued regarding the Power Station since the last Steering Group meeting in March. The message of establishing a public meeting has been passed on to Uniper.

Shropshire Council will continue to press for information on how the remaining structures will be maintained and secured for the future and for information on the Cooling Towers demolition process.
