**Intro:** Marion Blockley welcomed everyone to the meeting. The Chair introduced guest speakers, Stuart Ashton, Head of Planning and Claire Biddle, Planning Manager (Midlands), from the Harworth Group. A round-table introduction was conducted for the benefit of the guests.

## **Iron Bridge Power Station Site**

Stuart Ashton and Claire Biddle gave a presentation on the background of the Harworth Group and explained the initial plans for the Power Station site.

The Harworth Group have conducted several specialist meetings with Ironbridge area stakeholders and held a public meeting at the site on 10 October. Stakeholders and the public have been given the opportunity to send feedback with suggestions by 9 November. Feedback will be analysed by Harworth and made public, hopefully by February 2019, when further stakeholder and public consultation will be arranged.

Demolition work continues on the site. Major demolition work, including the removal of the Colling Towers and the Turbine Hall has gone out to tender. No dates have been given for the commencement of this work.

Harworth have made a commitment to keep the rail link to the site and showed plans to develop the terminus at the public consultation meeting on 10 October.

# Lighting Scheme for the Iron Bridge

The design of the lighting columns will be further examined following concerns raised by English Heritage.

The Chair reported that the scaffolding on the Iron Bridge is slowly being removed. The laying of the decking, which was delayed due to pipe work by Severn Trent Water, is scheduled to be completed by the beginning of November. Project completion date is now early December 2018. Plans for a type of opening ceremony are being discussed.
