

Getting Out and About:

Health and Wellbeing – The local offer and CCG information needs to be linked into Live Well Telford, all information in one place.

Lakewood Court update: Positive and exciting news!

Residential care home and wellbeing centre is going to be a supported living place for 16 people.

3 flats for 4 people.

4 individual flats.

People already living at Lakewood can stay if they choose to.

People will be able to use digital/assistive technology and a new garden area.

Wellbeing Centre:

Will have a better garden area at the back, sensory gardens and activity rooms and personal care areas inside.

2 new independent respite flats- there is enough room to have these and space for activity rooms for people to use.

People from the Wellbeing Centre will join in with activities at Southwood Hub Hollinswood.

Taking Part are talking to people to support them about the changes.

People will be able to look at plans on the new website. There is an action plan so people can check out what is happening.

It will be finished by spring 2023.
