May I attempt to address your concerns in the first instance.

- (i) It is general practice in Local Plan examinations not to publish administrative or procedural e-mails. However, the Inspector recognises that the matters raised in this exchange are likely to be of wider interest and as such has asked that they be made available as examination documents. He advises that he will be shortly sending a more formal document to the Council setting out his views on the examination's progress and a number of outstanding issues including potential soundness concerns.
- (ii) As you will be aware, the Inspector has generally discouraged the submission of further comments following the close of the hearing sessions the exceptions being specific cases (as agreed at the relevant hearings) where new evidence was accepted. He reiterates that there will be an opportunity for formal representations to be made as and when the Main Modifications are published. In the event that further new evidence is presented by the Council before that time, the Inspector will consider whether a specific consultation exercise is needed on a case-by-case basis.
- (iii) Specific notification of these documents was notified to matter 8 participants only as they have a specific interest in the matter. Unfortunately, it is not feasible for me to generally notify all reps whenever I add new documents to the website.

I have shared your concerns with the Inspector and will advise if he has anything further to add.

I hope this attends to your concerns however please let me know if otherwise.
