

Telford & Wrekin Council (Haygate Road, Wellington) (Prohibition of Waiting and Limited Parking) Traffic Regulation Order 2022

Notice is hereby given that the Borough of Telford & Wrekin in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2) and Part III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act hereby propose to make the following Order.

1. When this Order comes into effect;
 - (a) The Orders specified in the Schedule of Revocation of this Order shall have the effect of revoking the item specified in that schedule.
 - (b) Waiting will be prohibited at all times on the roads specified in Schedule 1 of this Order to the extent specified.
 - (c) Waiting will be restricted between the hours of 8am and 6pm on Monday to Saturday inclusive on the roads specified in Schedule 2 of this Order to the extent specified.
 - i. For a longer period than 1 hour; or
 - ii. If a period of less than 1 hour has elapsed since the termination of the last period of waiting by that vehicle.
2. A copy of the draft Order, the relevant plans, a statement of the Council's reasons for proposing to make the order, may be examined during usual office hours at Telford & Wrekin, Addenbrooke House, Ironmasters Way, Telford, TF3 4NT. (No waiting at any time)**

Column 1	Column 2	
1. Haygate Road, Telford And Wrekin (the north-west side)	From a point 33 metres south-west of the centre line for the junction of Alexandra Road in a north-easterly direction to a point 75 metres north-east of that centre line for that junction. From a point 93 metres north-east of the centre line for the junction of Alexandra Road in a north easterly direction to its junction with Bridge Road.	
2. Haygate Road, Telford And Wrekin (the south-east side)	From its junction with Wrekin Road in a south-westerly direction for a distance of 245 metres.	
3. Haygate Road, Telford And Wrekin (the south-west side)	From a point 156 metres north-east of its junction with Herbert Avenue in a north-easterly direction for a distance of 15 metres.	

**Schedule 2
(Parking Places - Time Limited Mon-Sat 8am-6pm 1 Hour - No Return Within 1 Hour)**

Column 1	Column 2	
1. Haygate Road, Telford And Wrekin (the north-west side)	From a point 75 metres north-east of the centre line for the junction of Alexandra Road in a north-easterly direction for a distance of 18 metres.
