Corporate tenancies Any tenancy where (to your knowledge)— N/A (a) the landlord is the Council: and (b) the tenant is a body in which you or your partner has a beneficial interest. **Securities** Any beneficial interest in securities⁶ of a body where-(a) that body (to your knowledge) has a place of business or land in the area of the Council: and (b) either-(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
