

# TELFORD & WREKIN COUNCIL (VARIOUS ROADS, APLEY CASTLE, TELFORD) (PROHIBITION OF WAITING & DISABLED BAY) EXPERIMENTAL ORDER 2021

Notice is hereby given that the Borough of Telford and Wrekin in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby propose to make the following order.

## TELFORD & WREKIN COUNCIL (VARIOUS ROADS, APLEY CASTLE, TELFORD) (PROHIBITION OF WAITING & DISABLED BAY) EXPERIMENTAL ORDER 2021

1. This Experimental Order will come into effect on Thursday 8<sup>th</sup> April 2021 for a period not exceeding eighteen months.
2. The effect of this Experimental Order: is parking will be prohibited at all times along the sides and lengths of road as described in Schedule One and Waiting will be restricted to the use of vehicles displaying a valid Disabled Person's Badge at all times on the length of roads specified in Schedule Two of this Order to the extent specified

### Schedule One Prohibition of Waiting

Apley Castle, Apley (the north-west side)	from its junction with Gatehouse Close in a north-easterly direction to its north-eastern extent from its junction with A5223 in a north-easterly direction to its junction with Gatehouse Close
Apley Castle, Apley (the south side)	from its junction with Castle Gardens in a westerly direction for a distance of 52m
Apley Castle, Apley (the south-east side)	from its junction with A5223 for a distance of 70m in a north-easterly direction from a point 80m north east of the junction with Apley Castle, Hospice Access Road in a south easterly direction for a distance of 28m from a point 78m north east of its junction with Apley Castle, Hospice Access Road in a south easterly direction for a distance of 89m from its junction with Castle Gardens in a easterly direction for a distance of 164m from a point 25 metres south-west of its junction with Apley Castle, Hospice Access Road in a north-easterly direction for a distance of 30m
Castle Gardens, Apley (both sides)	from its junction with Apley Castle in a southerly direction for a distance of 39m

### Schedule Two (Disabled Badge Holders Only)

Apley Castle, Apley (the north-east side)	from the gated access to Apley Woods in a southerly direction for a distance of 9m

Within a period of six months beginning with the day on which the Experimental Order came into force, or if any or all of the Experimental Order provisions are varied or modified by the Council, beginning with the day the latest variation or modification came into force, any person may object to the making permanent of the Experimental Order.
